MOTION/RECOMMENDATION:

Approve and authorize Chairman to execute amendment to the City of Winter Springs interlocal agreement for maintenance of the Cross Seminole Trail.

BACKGROUND:

On December 21, 1998 the BCC entered into an agreement with the City of Winter Springs for the design, construction and maintenance of portions of the Cross Seminole Trail within the City of Winter Springs Town Center.

The City of Winter Springs has requested an amendment to the agreement to extend the City's maintenance responsibilities to include an additional one (1) mile section of the trail from Central Winds Park to Layer Elementary School. This will enable the City to maintain trees in the area of the development known as Parkstone.

**SECOND AMENDMENT TO INTERLOCAL AGREEMENT BETWEEN THE CITY OF WINTER
SPRINGS AND SEMINOLE COUNTY FOR DESIGN, CONSTRUCTION AND MAINTENANCE
OF CERTAIN SECTIONS OF THE CROSS SEMINOLE TRAIL WITHIN THE CITY OF
WINTER SPRINGS TOWN CENTER**

THIS SECOND AMENDMENT is made and entered into this _____ day of _____, 20____ and is to that certain Interlocal Agreement made and entered into on the 21st day of December, 1998, as amended on October 24, 2002, between the **CITY OF WINTER SPRINGS**, a municipal corporation whose address is 1126 E. State Road 434, Winter Springs, Florida 32708, hereinafter referred to as the "CITY", and **SEMINOLE COUNTY**, a political subdivision of the State of Florida, whose address is Seminole County Services Building, 1101 East First Street, Sanford, Florida 32771, hereinafter referred to as the "COUNTY".

W I T N E S S E T H:

WHEREAS, the CITY and the COUNTY entered into the above referenced Interlocal Agreement on December 21, 1998, as amended on October 24, 2002, for design, construction and maintenance of portions of the Cross Seminole Trail/Florida National Scenic Trail ("CST/FNST") within the City of Winter Springs Town Center; and

WHEREAS, the parties desire to amend the Interlocal Agreement so as to extend the CITY's maintenance responsibilities to include an additional one (1) mile section of the CST/FNST, from Central Winds Park to Layer Elementary School in Winter Springs; and

WHEREAS, Section 6 of the Interlocal Agreement provides that the parties may enter into additional written agreements regarding the issues expressed herein,

NOW, THEREFORE, in consideration of the mutual understandings and agreements contained herein, the parties agree to amend the Interlocal Agreement as follows:


1. All provisions of the Interlocal Agreement entered into between the CITY and the COUNTY on December 21, 1998, as amended on

October 24, 2002 are extended to include that portion of the CST/FNST between Central Winds Park and Layer Elementary School in Winter Springs, as shown on Exhibit "A" attached hereto.

2. Except as herein modified, all terms and conditions of the Interlocal Agreement shall remain in full force and effect for the term of the Interlocal Agreement, as originally set forth in said Interlocal Agreement.


