MOTION/RECOMMENDATION: Approve and authorize the Chairman to execute the following: approval to submit a competitive grant proposal to the Emergency Management Municipal Competitive Grant/Emergency Management Preparedness and Assistance Trust Fund.			
BACKGROUND			
Each Florida County has a Comprehensive Emergency Management Plan (CEMP). As required by Florida Statute, the Florida Division of Emergency Management, Department of Community Affairs, approves each county's CEMP. Seminole County must submit an updated CEMP by the end of this year to be in compliance.			
Seminole's Emergency Management Division proposes to facilitate the planning process to update its CEMP with the expertise of an emergency response planning & management consulting firm. The project is expected to be a nine month process. The plan will be structured to parallel state and federal activities set forth in the "State of Florida Comprehensive Emergency Management Plan" and the "Federal Response Plan," and describe how state, federal and other resources will be coordinated to supplement county resources and respond to emergency situations.			
This planning project is consistent with the State Comprehensive Emergency Management Plan and applicable to submit for review to the Florida Emergency Management Municipal Competitive Grant Program. The due date is February 10, 2004.
