MOTION/RECOMMENDATION:

Approval and authorization for the Chairman to execute the attached Budget Amendment Resolution to transfer \$750,000 in reserve funds allocated in the Sheriff's FY 2003/04 adopted budget to the Sheriff's Office operating account.

BACKGROUND:

During the FY 2003/04 budget process, the Sheriff's Office proposed, and the Board of County Commissioners approved, \$750,000.00 in funding for staffing and start-up expenses at the new Criminal Justice Facility. Appropriated funding was placed in a Sheriff's Office reserve account until required. With the Facility still tentatively scheduled to open in September, 2004, the Sheriff's Office is now beginning a staggered hiring process to ensure the twenty-nine (29) new positions authorized to staff the Facility are hired and trained. The attached budget resolution moves the reserve funds to following appropriation categories: \$509,357.00 in personnel, \$117,363.00 in operating expenses, and \$123,280.00 for capital (29 radios, 1 vehicle, 5 computers and 1 shredder). All funds will be segregated in a specific expense cost center and any excess funds, if any, at the end of the year will be remitted to the County in accordance with State law.
