MOTION/RECOMMENDATION:

Approve and authorize an amendment to the 2001-2002 One-Year Action Plan of the 2000-2005 Five Year Consolidated Plan to create a new CDBG activity entitled "Kids House of Seminole, Inc.-New Building Construction."

BACKGROUND:

On 9/10/02 the Board approved funding to Kids House of Seminole, Inc. (Kids House) for the construction of a new building. The new building will provide Kids House the opportunity to increase its services to children victimized by various forms of assault.

In order to create this new activity and allocate the funds, the County is required by Federal Regulations (24 CFR 91.505) and the County's adopted Citizen Participation Plan (Section 9), to amend the 2001-2002 One-Year Action Plan by advertising the proposed Amendment and establishing a thirty (30) day public comment period for citizens to comment on the proposed Amendment.

The proposed Amendment was advertised in the Orlando Sentinel and the Seminole Herald on 12/29/02 and the public comment period expired on 1/28/03. Staff will forward public comments received to the Board prior to the BCC meeting.

Staff recommends that the Board approve the proposed Amendment and its submission to the US Department of Housing and Urban Development (HUD).

PROPOSED AMENDMENTS TO THE VOLUSIA/SEMINOLE CONSORTIUM'S 2000-2005 CONSOLIDATED PLAN ONE-YEAR ACTION PLAN FOR 2001-2002

On February 11, 2003 the Seminole County Board of County Commissioners will consider amending the 2001-2002 One-Year Action Plan of the County's 2000-2005 Consolidated Plan. The Five-Year Consolidated Plan and its corresponding One-Year Action Plans governs the allocation and expenditure of CDBG Program funds. Under the proposed amendment, the Board would fund a new CDBG activity which would allocate funds for the construction of a new building to improve services being provided by Kids House of Seminole, Inc.
