RESOLUTION

**THE FOLLOWING RESOLUTION WAS ADOPTED AT
THE REGULAR MEETING OF THE BOARD OF COUNTY
COMMISSIONERS OF SEMINOLE COUNTY, FLORIDA
ON THE 13th DAY OF FEBRUARY, 2007.**

WHEREAS, Habitat for Humanity in Seminole County, Florida, Inc. (Habitat), is a 501 C-3 not for profit organization created to construct homes and offer home ownership to very low-income residents in an effort to eliminate substandard housing and develop a healthy, safe and economically viable community; and

WHEREAS, the Habitat building program makes owner-occupied housing available to all eligible persons through private-public partnerships and "sweat equity" on the party of purchasing persons; and

WHEREAS, Chapters 212, 220, and 624 of the Florida Statutes, provide corporate income tax, insurance premium tax, and tax funds as the community contribution tax credit, as set out in sections 212.08 (5)(q) 220.183 and 624.5105 of the Florida Statutes and in Rule 8E-17 of the Florida Administrative Code, as an incentive to donate materials to eligible projects for the construction of low-income housing; and

WHEREAS, the criteria set forth in the Florida Statutes require certification by local government that projects are consistent with local plans and regulations as included in the application for the community contribution tax credits.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY
COMMISSIONERS OF SEMINOLE COUNTY, FLORIDA:**

Section 1. Seminole County supports Habitat's building program which provides for the construction of housing for very-low income residents of the Cities of Casselberry, Sanford, Lake Mary, Altamonte Springs, Winter Springs, Longwood and Oviedo, and the surrounding areas, including Geneva and Chuluota.

Section 2. Habitat's building program is consistent with the provisions of the Comprehensive Policy Plan of Seminole County and all local plans and regulations.

Section 3. The Seminole County Clerk to the Board of County of Commissioners is hereby authorized and directed to file this Resolution with the State of Florida, of Tourism, Trade and Economic Development of the Executive Office of the Governor, The Capital, Suite 2001, Tallahassee, Florida 32399-0001, to enable Habitat to obtain approval for its projects.

Section 4. If any provision of this Resolution or the application thereof to any person or circumstance is held invalid, the invalidity shall not affect other provisions or applications of this Resolution which can be given effect without the valid provision or application and to this end the provisions of this Resolution are declared severable.

Section 5. This Resolution shall take effect immediately.

NOW THEREFORE, BE IT FURTHER RESOLVED, that this Resolution be spread upon the Official Minutes by the Clerk to the Board of County Commissioners of Seminole County, Florida.
