**MOTION/RECOMMENDATION:**

Approval by the Board of County Commissioners of the attached budget amendment increasing the Sheriff's Office FY 2006/07 budget by \$28,748.

The Sheriff's Office has now accrued \$28,748 in unclaimed evidence funds, which in accordance with section 705.105, Florida Statutes become the property of the Sheriff's Office. The Sheriff's Office does not budget for unclaimed evidence funds in its annual budget since receipt of these funds is totally dependant upon the disposition of cases and therefore may fluctuate significantly from year to year. At such time during the year that these revenues do accrue in a sufficient amount to warrant appropriation by the Board of County Commissioners, an agenda item is prepared. These funds will be utilized within the Sheriff's budget for operating needs within the agency.
