MOTION/RECOMMENDATION:

Adopt and authorize Chairman to execute a Resolution naming an unnamed platted street to Vista Lake Court

(District 5-Carey)

BACKGROUND:

An unnamed platted street is located in the recorded plat of Howard Packard Land Cos 1st Add to Cameron City, Plat Book 1 Page 70. This unnamed platted street serves as the main access for two residences. These residences are currently addressed to Michigan Ave, however, their access is from the unnamed platted street. To avoid confusion and delays in emergency response, the 9-1-1 Committee unanimously recommended a request to name the unnamed platted street.



Staff recommends naming the unnamed platted street to Vista Lake Court



RESOLUTION NO. 2006-R-_____ SEMINOLE COUNTY, FLORIDA

THE FOLLOWING RESOLUTION WAS ADOPTED BY THE BOARD OF COUNTY COMMISSIONERS OF SEMINOLE COUNTY, FLORIDA, AT THEIR REGULARLY SCHEDULED MEETING OF, APRIL 11, 2006

WHEREAS, under the authority contained in Section 336.05 (1) and 336.05 (2), Florida Statutes, the Board of County Commissioners may name and rename streets and roads; and

WHEREAS, a request has been received to name an unnamed platted street located in Howard Packard Land Cos 1st Add to Cameron City, Plat Book 1 Page 70, in Section 9 Township 20 Range 31 Public Records of Seminole County, Florida.

WHEREAS, naming this street will help to eliminate confusion, facilitate improved emergency access and ability of the public to locate streets and roads within Seminole County, and,

WHEREAS, this change is consistent with overall County plans for street naming, addressing and the 911 system.
