**BACKGROUND:**

The Federal Highway Administration (FHWA) has established an Emergency Relief Program for County roadways on the Federal Aid System that were damaged by hurricanes Charley, Frances and Jeanne and has authorized the Florida Department of Transportation (FDOT) to administer funding for this. This Amendment Number 1 to the Emergency Relief Program Agreement executed on January 31, 2005, changes the current DDIR account numbers associated with Hurricane Frances.
