14. Approve Mutual Termination for RFP-4229-04/GMG - Mobile Unit Concession Operations Agreement for Seminole County Red Bug Lake Park, with P.T. Enterprises, Apopka (Revenue Agreement).

RFP-4229-04/GMG provides for mobile concession services for the Seminole County Red Bug Lake Park.

On December 14, 2004, the Board of County Commissioners awarded the Concession Operations Agreement for Seminole County Red Bug Lake Park to P.T. Enterprises, Apopka. P.T. Enterprises notified the Purchasing and Contracts Division that the company can no longer comply with the requirements of the scope of work due to the owner's primary permanent job commitments and has requested the termination of their agreement. The Purchasing and Contracts Division is in process of preparing a new solicitation.

Administrative Services Department/Support Services Division; Library and Leisure Services Department/Parks and Recreation Division and Fiscal Services Department/Purchasing and Contracts Division recommend the Board to approve the mutual termination and authorize the County Manager to execute the document as approved and prepared by the County Attorney's Office.
