RESOLUTION

THE FOLLOWING RESOLUTION WAS ADOPTED AT THE REGULAR MEETING OF THE BOARD OF COUNTY COMMISSIONERS OF SEMINOLE COUNTY, FLORIDA ON THE 13th DAY OF APRIL, A.D., 2004.

WHEREAS, WILLIAM "BILL" MILLER, has been a Florida resident since leaving his home state of Pennsylvania in 1979, and an outstanding businessman in Central Florida since founding Suda, Inc. and constructing more than 1,200 single-family homes over a quarter century; and

WHEREAS, BILL MILLER has performed outstanding service to his community for twenty-five years on the Seminole County Building Contractors Board, Sanford Airport Authority Board, Private Business Association of Seminole, Better Business Bureau of Central Florida, Spring Valley Farms Community Association, Ocean Inlet Condominium Board, Rescue Outreach Mission of Sanford, Seminole Children's Village, Hospice of the Comforter, Rotary Club of South Seminole County, Wekiva River Resource Council, Greater Seminole County Chamber of Commerce, Seminole Community College Dream Auction, MetroPlan Orlando Citizen Advisory Committee, South Seminole Community Hospital Board, and the HBA Advisory Committee to Seminole County; and
