27. Approve Amendment #2 to M-336-02/BJC – Concrete Telecommunications Shelter, with Tower Systems South, Inc., Winter Park (\$54,176.00).

M-336-02/BJC provides for correspondence and approvals, site acquisition, utilities/emergency generators, site grounding, electrical and HVAC, inventory, space, site access, zoning and permitting and site utilization to include tower structural upgrade.

Amendment #2 will provide for the ancillary tower and building work necessary to bring on the additional Oviedo site, Sabal Point equipment and microwave optimization. During the assessment of the sites, microwave coordination, tower work for the project and additional scope was developed to provide structural upgrade, equipment, and configurations for the completion of the System Enhancement Project (M-317-02/BJC) with Motorola, approved by the Board of County Commissioners on June 11, 2002. SECOND AMENDMENT TO CONCRETE TELECOMMUNICATIONS SHELTER INSTALLATION AGREEMENT (M-336-02/BJC)

THIS SECOND AMENDMENT is made and entered into this ______ day of _______, 20____ and is to that certain Agreement made and entered into on the 30th day of October, 2002, as amended on February 21, 2003, between TOWER SYSTEMS SOUTH, INC., whose address is 3075 North Forsyth Road, Winter Park, Florida 32792, hereinafter referred to as "CONTRACTOR," and SEMINOLE COUNTY, a political subdivision of the State of Florida, whose address is Seminole County Services Building, 1101 East First Street, Sanford, Florida 32771, hereinafter referred to as "COUNTY".

WITNESSETH:

whereas, the CONTRACTOR and COUNTY entered into the above-referenced Agreement on October 30, 2002, as amended on February 21, 2003, for delivery and installation of a concrete telecommunications shelter; and

WHEREAS, the parties desire to amend the Agreement so as to enable both parties to continue to enjoy the mutual benefits it provides; and

WHEREAS, Section 18 of the Agreement provides that any amendments shall be valid only when expressed in writing and duly signed by the parties,

NOW, THEREFORE, in consideration of the mutual understandings and agreements contained herein, the parties agree to amend the Agreement as follows:

1. Section 3 of the Agreement is amended to read:

SECTION 3. FIXED FEE COMPENSATION AND PAYMENT.

(a) The COUNTY agrees to compensate CONTRACTOR for the professional services called for under this Agreement a fixed fee in the amount of ONE HUNDRED SEVENTY-ONE THOUSAND FOUR HUNDRED SEVENTY-THREE AND NO/100 DOLLARS (\$171,473.00). CONTRACTOR shall perform all work required by the Scope of Services but, in no event, shall CONTRACTOR be

paid more than the negotiated Fixed Fee amount stated above.

- (b) Payments shall be made to the CONSULTANT when requested as work progresses for services furnished, but not more than once monthly. CONTRACTOR may invoice amount due based on the total required services actually performed and completed. Upon review and approval of CONTRACTOR's invoice, the COUNTY shall, within thirty (30) days of receipt of the invoice, pay CONTRACTOR the approved amount.
- 2. Exhibit "A" of the Agreement is amended by the addition of additional services as outlined in Exhibit "A" attached hereto.
- 3. Except as herein modified, all terms and conditions of the Agreement shall remain in full force and effect for the term of the Agreement, as originally set forth in said Agreement.
