Approve to submit a grant application to the Department of Community Affairs for the purchase of land at Jetta Point Park, and authorize the County Manager to execute supporting documents.



BACKGROUND:

The Florida Department of Community Affairs is offering the Florida Communities Trust, Florida Forever grant program to provide funding for the purchase of land for community-based parks that enhance opportunities for outdoor recreation.

Seminole County previously purchased two parcels adjacent to Jetta Point Park to expand the development of the site. The grant, if awarded, would reimburse the county for the cost of the two parcels plus provide funding for an additional 1.46 acres. The additional parcel would further expand the development of Jetta Point Park.

The proposed application would request \$270,000 with a 25% match. The land previously purchase is sufficient to meeting the grant match requirement.
