**MOTION/RECOMMENDATION**

Approval and authorization for the Chairman to adopt a resolution establishing the new assessment rate for each MSBU with provisions for establishing revised assessment rates on an annual basis.

**BACKGROUND**

This resolution is an annual requirement for the existing MSBUs that have variable assessment rates. This resolution establishes the assessment rates for MSBUs that by the nature of services or improvements provided, as well as being in accordance with ordinance provisions, are subject to annually determined assessment rates. The resolution confirms the expectation that the lien for the assessment is considered satisfied for the year upon payment of the assessment amount.

In prior years, this resolution was titled "Annual Maintenance Resolution" and the rate adjustments listed in the exhibits were limited to aquatic weed control and landscape maintenance related assessments. In effort to improve communications and to give clarity to rate adjustments, the new assessment rates for all MSBUs with variable rates are included in this year's Resolution. The title of this revised resolution has been changed to reflect the intent of the contents - Variable Rate Assessment Maintenance.

The exhibited rates will be included on the 2006 Notice of Proposed Non-Ad Valorem Assessment scheduled for distribution to property owners in early August.

Summary : Assessment Changes from 2005 to 2006

**Aquatic Weed Control**

Howell Creek – increase from .20 front foot to .30 front foot per with anticipation that aquatic weed control expenditure in current fiscal year or next will be at a level that will draw heavily on the contingency fund

Lake Pickett – increase from \$25 to \$50 per lot; treatments are often required every 3 to 4 year; treatment requirements and cost increases in current fiscal year placed heavy draw on contingency funds; rate has been increased to provided growth of reserve funds for future treatments, status/situation will be communicated to participating properties via letter in late July (prior to mailing of Non-Ad Valorem Notices).

**Landscape Maintenance**

Cedar Ridge – increase from \$157 to \$165 [\$8; 5.1%] to cover increased expenses associated with irrigation equipment repairs, increases in electrical utility costs, and other projects targeted by liaisons.

**Solid Waste**

Service Options - Increases range from 4.3 to 5.2 percent [\$3 to \$9] primarily to accommodate hauler rate increase [application of CPIU rate] in current fiscal year and expectations of similar increase in new year.

**Street Lighting**

From assessment year 2004 to assessment year 2005 and from assessment year 2005 to assessment year 2006, as documented through electric utility bills, the utility expenditures for many districts have increased significantly. The increases noted are associated with storm recovery fees, fuel fees, and base electric usage charges. In summary:

- 68 districts had utility increases in the 10%-20% range
- 274 districts had utility increases in the 20%-30% range
- 7 districts had utility increases greater than 30%

During FY005, contingency funds are being used to cover the increased costs since the assessment (primary revenue source) rates (calculated based on estimated costs) do not cover the actual costs being incurred. As a result of shifting contingency funds to utility expenditure lines, the contingency funds carried over into FY0607 will be low or depleted.

The requested assessment revenue increases reflect the impact of the increased utility cost and contingency status. Additional increases are reflected in several districts due to requested equipment upgrades to be effective in FY0607. In summary:

- 115 districts will increase 10%-20%,
- 192 will increase 20%-30%, and
- 29 will increase over 30%.

The adjustments requested for the FY0607 budget are necessary to provide coverage of current utility rates plus a projected increase of 10%, and for providing a per district contingency fund of at least 10%. Our goal for street lighting is to establish a contingency fund set at 20% of budgeted utility expenses. However, given the significant impact of the utility costs on the FY0607 assessment rates to property owners, we are budgeting contingency at approximately 17% of projected (budgeted) utility expenses.

THE FOLLOWING RESOLUTION WAS ADOPTED BY THE BOARD OF COUNTY COMMISSIONERS OF SEMINOLE COUNTY, FLORIDA, AT THEIR REGULARLY SCHEDULED MEETING ON MAY 9, 2006.

**WHEREAS**, certain Municipal Service Benefit Units ("Unit" or "Units") have been created by ordinance for the purpose of providing specific services and/or improvements within each Unit on a continuing basis; and

**WHEREAS**, each year for each Unit an assessment is calculated based upon cost of providing the service for that Unit for that year and that annual assessment constitutes a lien upon the lands assessed within the Unit; and

**WHEREAS**, such assessment is levied upon each parcel of land within the Unit in proportion to the benefits derived from the provisions of such service; and

**WHEREAS**, once an annual assessment is paid for lands assessed, the annual lien for the assessment on those lands is satisfied; and

**WHEREAS**, for public record and official record purposes it is deemed essential to record annually a list of annually revised assessments so that such liens may be easily identified and satisfaction recorded upon payment;

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SEMINOLE COUNTY, FLORIDA, THAT:**

**Section 1.** Exhibits "A1", "A2", "A3", and "A4" attached and incorporated herein hereby establish the assessments for services to the listed Municipal Service Benefit Units and referenced parcels for the fiscal year October 1, 2006 until September 30, 2007. Exhibit "B" attached and incorporated herein hereby establishes the assessments for solid waste collection and/or disposal services coordinated through the Municipal Service Benefit Units for calendar year 2007; beginning January 1, 2007 through December 31, 2007. Exhibit "C" attached and incorporated herein hereby establishes the assessments for street lighting improvements coordinated through the Municipal Service Benefit Units for fiscal year October 1, 2006 until September 30, 2007.

**Section 2.** For each parcel listed and/or included in the exhibited MSBUs, the lien for that assessment shall be deemed satisfied upon payment of the assessment amount for said parcel.
