BACKGROUND:

- \$250 contribution to the Missing Children Clearing House Advisory Board.**
 The Missing Children Clearing House Advisory Board, a component of the Florida Department of Law Enforcement (FDLE) helps highlight the plight of missing children by sponsoring an annual Florida Missing Children Day, which was enacted by the Florida Legislature in 1999. This statewide ceremony honors police officers and civilians who have assisted in missing child cases and raised statewide awareness to help prevent child abduction and sexual exploitation. The annual ceremony, which will be held on September 13, 2004 in Tallahassee will be attended by Governor Bush, governmental dignitaries from throughout Florida, law enforcement officials and hundreds of parents and children. The Sheriff's Office desires to contribute \$250 to The FDLE's Missing Children Clearing House Advisory Board to assist them in planning and funding this very worthwhile event.
