Approval by the Board of County Commissioners to expend \$1,000 from the Law Enforcement Trust Fund to contribute to the Orlando Police Department in support of the Florida Police Chiefs Association's Summer Conference.

BACKGROUND:

SUBJECT: Board of County Commissioners Meeting – Agenda Items

Attached to this correspondence are three (3) agenda items requesting Board of County Commission approval for the following items:

- Law Enforcement Trust Fund expenditure in the amount of \$1,000.00 for a contribution to the Orlando Police Department in support of the 2003 Florida Police Chiefs Summer Conference, which members of the Sheriff's Office will be attending.
- A Budget Amendment Request (BAR) authorizing the transfer of \$36,294.00 in Law Enforcement Trust Fund monies to the Sheriff's Office General Fund Budget. Transfer of these funds will allow the Sheriff's Office to match grant funds already budgeted within the Sheriff's General Fund budget for the purchase of emergency response clothing.
- A Budget Amendment Request (BAR) increasing General Fund revenues and the Sheriff's Office expense budget by \$65,000.00. These funds have recently been granted to the Sheriff's Office by the Florida Department of Law Enforcement for financial assistance with complex investigations.

It is respectfully requested that the above agenda items be placed on the agenda for the Board of County Commissioners meeting on Tuesday, May 13, 2003.
