BACKGROUND:			
At the time the plat of Forest Slopes was recorded, August 20, 1957, Jewel Drive was intended to be a contiguous street from SR 436 to its conclusion just north of Virginia Drive. A ditch for drainage purposes runs through the plat; over the course of time the ditch became a canal bisecting Jewel Drive between lots 19 and 20. The only access to lots 17, 18 and 19 is by way of Virginia Drive to Turner Lane.			
Turner Lane is an established private road north of the plat of Forest Slopes. At this time there is a street sign installed and the property owners for lots 17 and 18 are addressed to Turner Lane.

Dear Property Owner:

In the interest of public safety, Seminole County received a request from the 911 Emergency Communications Office to rename a portion of Jewel Drive, a street segment located within the recorded plat of Forest Slopes, Plat Book 11 Page 52 lots 16, 17 18 and 19; public records of Seminole County, Florida to Turner Lane. Pursuant to Seminole County Ordinance 2000-22, we are required to notify property owner abutting this street segment of our intent to pursue street renaming.

Currently, Jewel Drive is not contiguous from SR 436 to its conclusion just north of Virginia Drive, it is bisected by a large drainage ditch. At this time, in the event of a 911 call, there is a concern that emergency vehicles may be delayed responding to the segment of Jewel Drive north of the ditch. The proposed renaming of Jewel Drive north of the ditch to Turner Lane would not only assist emergency response to a 911 call, but, it would assist with normal daily deliveries.
