BACKGROUND:



Sunny-Side Avenue is located in the recorded plat of Section 2 Midway Parks, Plat Book 4 Page 96 1/2. This street was platted using a hyphen; which has created confusion regarding the street spelling. Additionally, the use of a hyphen creates problems with the E-911 database since the use of symbols has special meaning. To avoid confusion and delays in emergency response, the 9-1-1 Committee unanimously recommended a request to rename the platted street to Sunnyside Avenue.

The abutting property owners were notified of the intent to rename the street in order to correct the plat of record. To date there is no opposition to the new name.

Staff recommends renaming Sunny-Side Avenue to Sunnyside Avenue.




RENAMING SUNNY - SIDE AVE TO SUNNYSIDE AVE




AVALONA DR





RESOLUTION NO. 2006-R-_____ SEMINOLE COUNTY, FLORIDA

THE FOLLOWING RESOLUTION WAS ADOPTED BY THE BOARD OF COUNTY COMMISSIONERS OF SEMINOLE COUNTY, FLORIDA, AT THEIR REGULARLY SCHEDULED MEETING OF, MAY 23, 2006

WHEREAS, under the authority contained in Section 336.05 (1) and 336.05 (2), Florida Statutes, the Board of County Commissioners may name and rename streets and roads; and

WHEREAS, a request has been received to rename a platted street in Section 2 Midway Parks, Plat Book 4 Page 96 ½, in Section 22 Township 20 Range 30 of the Public Records of Seminole County, Florida; and

WHEREAS, renaming this street will help to eliminate confusion, facilitate improved emergency access and ability of the public to locate streets and roads within Seminole County; and

WHEREAS, this change is consistent with overall County plans for street naming, addressing and the 911 system,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SEMINOLE COUNTY, FLORIDA, that effective, MAY 23, 2006, the street is named as follows:
