BACKGROUND:




The new roadway, commonly referred to as the East Lake Mary Boulevard extension, located between Red Cleveland Boulevard and East State Road 46 is nearing completion. Addressing staff received a request from Public Works Department/ Engineering Division to legally name the roadway. The new roadway is a continuation of East Lake Mary Boulevard.

The abutting property owners were notified of the intent to name the roadway. No opposition has been received regarding this street naming.




RESOLUTION NO. 2006-R-_____ SEMINOLE COUNTY, FLORIDA

THE FOLLOWING RESOLUTION WAS ADOPTED BY THE BOARD OF COUNTY COMMISSIONERS OF SEMINOLE COUNTY, FLORIDA, AT THEIR REGULARLY SCHEDULED MEETING OF, MAY 23, 2006

WHEREAS, under the authority contained in Section 336.05 (1) and 336.05 (2), Florida Statutes, the Board of County Commissioners may name and rename streets and roads; and

WHEREAS, a request has been received to name an unnamed roadway located between Red Cleveland Boulevard and East State Road 46. The new roadway eliminates a portion of Kentucky Street, west of Sipes Avenue, within Seminole Gardens Plat Book 5 Page 2, abutting Lots 1, 16 and 16A; Palmers Subdivision Plat Book 2 Page 41, abutting lots 38B, 32, 6, 6C, 17, 16, and 15. The new roadway eliminates a portion of a platted roadway known as Bridges Road, located east of Beardall Avenue, abutting lots 42, 42A, 42B, 42C, 42D, 42E, 55 and 56 within Celery Delta Plat Book 1 Page 76, Public Records of Seminole County, Florida.

WHEREAS, naming this street will help to eliminate confusion, facilitate improved emergency access and ability of the public to locate streets and roads within Seminole County, and,

WHEREAS, this change is consistent with overall County plans for street naming, addressing and the 911 system.

NOW, THEREFORE, BE IT RESOLVED, that effective, MAY 23, 2006, the street is named as follows:
