

**17. Approve Amendment #4 to M-93-99/BJC – Copier Services, with Lanier Worldwide, Inc., Orlando (Update Exhibits “A” and “B” – List of equipment).**

M-93-99/BJC provides for a variety of services in connection with the County’s use of the copying equipment owned by the County and identified in Exhibits “A” and “B” as part of the backup documents. Amendment #4 will replace Exhibits “A” and “B” with a current list of copying equipment. No additional funds are required for this amendment.

Administrative Services/Support Services and Fiscal Services/Purchasing and Contracts Division recommend the Board to approve and authorize the Chairman to execute the Amendment as approved and prepared by the County Attorney Office.

**FOURTH AMENDMENT TO COPIER SERVICES AGREEMENT (M-93-99/BJC)**

**THIS FOURTH AMENDMENT** is made and entered into this \_\_\_\_\_ day of \_\_\_\_\_, 20\_\_\_\_ and is to that certain Agreement made and entered into on the 25<sup>th</sup> day of June, 1999 between **LANIER WORLDWIDE, INC.**, whose address is 1991 Summit Park Drive, Orlando, Florida 32810, hereinafter referred to as "LANIER," and **SEMINOLE COUNTY**, a political subdivision of the State of Florida, whose address is Seminole County Services Building, 1101 East First Street, Sanford, Florida 32771, hereinafter referred to as "COUNTY".

**WHEREAS**, LANIER and COUNTY entered into the above-referenced Agreement on June 25, 1999, as amended on September 15, 2000, August 13, 2001, and on August 19, 2002 for copier services; and

**WHEREAS**, Section 8 of the Agreement dated June 25, 1999 provides that any amendments shall be valid only when expressed in writing and duly signed by the parties,

**NOW, THEREFORE**, in consideration of the mutual understandings and agreements contained herein, the parties agree to amend the Agreement as follows:

1. Exhibits "A" and "B" of the Agreement are deleted and Exhibits "A" and "B" attached hereto are substituted therefore.
2. Except as herein modified, all terms and conditions of the Agreement shall remain in full force and effect for the term of the Agreement, as originally set forth in said Agreement.
