WHEREAS, *Mary Mantzaris transferred to the the County Manager's Office and served as Executive Assistant to Acting County Manager Robert McMillan, from 1989-1991; County Manager Ron Rabun from 1991-1996; County Manager Gary Kaiser from 1996-1999; and County Manager Kevin Grace from 1999 to the present; and*

WHEREAS, *Mary Mantzaris served as Secretary to the Charter Review Commission; Secretary to the Seminole County Legislative Delegation; and served on the Volunteer Reception Committee each year since its inception; and*

WHEREAS, *Mary Mantzaris was selected Employee of the Year for 2002 and Employee of the Month for June, 1993; and*

WHEREAS, Mary Mantzaris has shown exceptional dedication and willingness to accept every role and responsibility given her; superlative coordination skills, patience and perseverance in keeping the County's Agenda process on schedule; and instilled the values of efficiency, professionalism, accountability and integrity in the County Manager's Office and throughout the work place; and consistently displayed pride, fairness and personal honesty; and

Whereas, Mary Mantzaris will officially be retiring effective June 30, 2003 and will truly be missed by her fellow employees and many friends alike; and

Whereas, the Board of County Commissioners of Seminole County, Florida, wishes to commend Mary Mantzaris for her dedication, faithful service, and commitment to Seminole County, its employees and its citizens during more than twenty-five years of public service; and
