**MOTION/RECOMMENDATION:**

Adopt Resolution renaming a segment of State Road 436 to East Altamonte Drive; and authorize Chairman to execute document.

**BACKGROUND:**

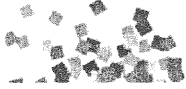
The duplication of address numbers on east and west State Road 436 between I-4 easterly to the Orange County line recently caused emergency response delays to a 911 call. In a combined public safety effort to alleviate confusion a request was received from the Seminole County 911 Office and the Casselberry Fire Department to rename the segment of State Road 436 between I-4 and US Highway 17-92 to East Altamonte Drive. At the present time, the majority of businesses along this segment of State Road 436 use the street name East Altamonte Drive as their address.

The property owners and businesses along this segment of State Road 436 were notified of our intent to rename the street to East Altamonte Drive, to date we have not received a response from anyone in disagreement.

Staff recommendation is to rename this segment of State Road 436 to East Altamonte Drive.

Hi Maggie,

After an in-dept review and discussion by the Seminole County 9-1-1 Addressing committee which includes representatives from the Seminole County Sheriff's Office, the City of Casselberry, Altamonte Springs, and unincorporated Seminole County, it was determined that it is in the best interest of the community and emergency response to rename the West side of Highway 17-92 from E State Rd 436 to E Altamonte Dr. This only affects the unincorporated address as the City Altamonte Springs already uses E Altamonte Dr.

The committee determined that on East side of Highway 17-92 for consistency, all addresses will be addressed to State Rd 436, and the use of Semoran will no longer be approved or issued by county addressing.

Dear Ms. Ketcham:

Because of confusion generated by the duplications of addresses on east and west SR 436, a significant response delay occurred following a recent 9-1-1 call. In accordance with our Interlocal Agreement, please consider this writing my official endorsement of the following street change proposal by the Seminole County Addressing Committee:

1. From I-4 to US 17-92 designate SR 436 as "East Altamonte Drive." This will probably affect about 15 businesses in Casselberry.
2. West of 17-92 to the Orange County line designate SR 436 as "State Road 436."
3. South of the Orange County line to the airport SR 436 remain as "Semoran Blvd."

Your consideration and implementation of this proposal, addresses several key issues:

1. NO address numbers will be changed!
2. NO directional designations will be required for SR 436. The numbers do not require changing and with SR 436 between 17-92 and I-4 becoming "East Altamonte Drive," there should no longer be any duplications of addresses on SR 436 in Casselberry.
3. The only directional designations will be required on "Altamonte Drive" with I-4 acting as the dividing line.
4. The Post Office will continue to deliver mail to all patrons located on SR 436, regardless of the street name used, due to their use of an "alias" which allows both their letter carriers and sorters to determine an actual intended address.
5. This will create distinct and specific addresses for the County 9-1-1 dispatchers to utilize, both for Casselberry's Fire Department, as well as outside agencies that could respond to an address as part of the City's Interlocal Agreement.

WHEREAS, a request has been received to rename a segment of State Road 436 located in Section 17 Township 21 Range 30, between I-4 and US Highway 17-92, Public Records of Seminole County, Florida.
