MOTION/RECOMMENDATION:

Request approval and execution of the resolution to transfer title and possession of furnishings and equipment to the State of Florida as mandated by F.S. 29.008.

BACKGROUND:

Section 29.008 (1) (a) 2, Florida Statutes requires the County to transfer title and possession of furnishings and equipment located in the non-public areas of court facilities within the County at no charge to the State of Florida, by July 1, 2005.

The county's responsibility for equipment/furnishings will be limited to what is considered appropriate and customary for courtrooms, jury facilities, and other public areas in the facilities occupied by the courts, state attorneys and public defenders.

The Office of the State Courts Administrator is the designated agency for the transfer transaction, and has provided the attached "Property Transfer Form 29.008" for use in accomplishing the required transfers.

County Staff has provided a comprehensive "Inventory List", of which County staff and local representatives of the State's Court Administration have together verified County ownership and inventory location.

Upon approval and execution of the resolution by the BCC, the County Manager is authorized to execute the property transfer form, which will relinquish and transfer the County's title to the items included in the Inventory List to the State Court System.

THE FOLLOWING RESOLUTION WAS ADOPTED BY THE BOARD OF COUNTY COMMISSIONERS OF SEMINOLE COUNTY, FLORIDA, AT THEIR REGULARLY SCHEDULED MEETING OF _____, 2005.

WHEREAS, section 29.008(1)(a)2, Florida Statutes requires the County to transfer title and possession of certain furnishings and equipment located in non-public areas of the courthouse facilities within the County at no charge to the State of Florida by no later than July 1, 2005; and

WHEREAS, the Office of the State Courts Administrator has promulgated Property Transfer Form F.S. 29.008, attached hereto as Exhibit "A", for use by all Florida counties and local trial courts in accomplishing the required property transfers (hereinafter referred to as "Form 29.008"); and

WHEREAS, County staff has heretofore provided a comprehensive inventory list of the equipment and furnishings located in the two courthouse complexes within the County which are to be transferred to the State Court System and which are attached hereto as Exhibit "B" (hereinafter referred to as the "Inventory List"); and

WHEREAS, County staff and representatives from the local office of Court Administration have together reviewed and agreed upon the completeness, accuracy and whereabouts of all component parts of the Inventory List,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SEMINOLE COUNTY, FLORIDA, THAT:

1. The above recitals are incorporated herein by reference and form an integral part of this Resolution.

2. Form 29.008 is hereby approved as to form and content and is incorporated herein by reference. The County Manager is hereby authorized to execute said form on behalf of the County on or before July 1, 2005.

3. The Inventory List is hereby found to be true and complete as to the entirety of the furnishings and equipment that shall be transferred to the State Court System upon execution and delivery of Form 29.008. The Inventory List shall be attached as an Exhibit to Form 29.008 and shall be deemed an integral part of said document and incorporated therein by reference.

4. The Board of County Commissioners hereby represents and declares that it has good and marketable title to each and every component of the Inventory List and that it has the authority to transfer same to the State Court System.

5. Execution of Form 29.008 shall immediately effect the relinquishment and transfer of all the County's title, rights and control of all items comprising the Inventory List in favor of the State Court System in and for Seminole County, Florida.

6. This Resolution shall take effect upon its adoption as of the date below.
