**MOTION/RECOMMENDATION:**

Approve amendment to Orange County Library System Reciprocal Borrowing Agreement.

**BACKGROUND:**

On September 10, 1998 the Seminole County Public Library System entered into a Reciprocal Borrowing Agreement with the Orange County Library System. In April 2002 staff was notified that Orange County had added DVD's to their collection and these would not be made available for circulation to Seminole County residents. In January 2003 the agreement was amended to reflect this change by limiting materials eligible for lending to books, audio books, books on compact disc, music on compact disc, videos, periodicals and record books.

In August 2004 staff was notified that Orange County will be further limiting materials available to Seminole County residents. Effective August 1, 2005, audiovisual materials are no longer eligible for reciprocal borrowing. Services to be provided are the lending of books only.

**SECOND AMENDMENT TO INTERLOCAL AGREEMENT FOR RECIPROCAL BORROWING  
BETWEEN ORANGE COUNTY LIBRARY SYSTEM AND SEMINOLE COUNTY LIBRARY SYSTEM**

**THIS SECOND AMENDMENT** is made and entered into this 12<sup>th</sup> day of May, 2005 and is to that certain Agreement made and entered into on the 29<sup>th</sup> day of September, 1998, as amended on January 23, 2003, between the **ORANGE COUNTY LIBRARY DISTRICT**, an independent special district, by and through its Board of Trustees, whose address is 101 East Central Boulevard, Orlando, Florida 32801-2471, hereinafter referred to as the "District," and **SEMINOLE COUNTY**, a political subdivision of the State of Florida and governing authority of the Seminole County Public Library System, by and through its Board of County Commissioners, whose address is Seminole County Services Building, 1101 East First Street, Sanford, Florida 32771, hereinafter referred to as "Seminole County".

**W I T N E S S E T H:**

**WHEREAS**, the District and Seminole County entered into the above-referenced Agreement on September 29, 1998, as amended on January 23, 2003, to enhance and facilitate library services in the Central Florida area; and

**WHEREAS**, the parties desire to amend the Agreement so as to enable both parties to continue to enjoy the mutual benefits it provides,

**NOW, THEREFORE**, in consideration of the mutual understandings and agreements contained herein, the parties agree to amend the Agreement as follows:

1. Article 3.2 of the Agreement is amended to read:

3.2 The only services to be provided to Resident Borrowers of the other party are the lending of materials over the counter at one of the libraries of each party. Materials eligible for lending are limited to circulating books only. No lending services by computer or mail will be offered by either party under this Agreement

to the resident borrowers of the other party.

2. This Second Amendment shall take effect on August 1, 2005.

3. Except as herein modified, all terms and conditions of the Agreement shall remain in full force and effect for the term of the Agreement, as originally set forth in said Agreement.
