Pursuant to FS 741.30 (Domestic violence; injunction; powers and duties of court and clerk; petition; notice and hearing; temporary; issuance of injunction; statewide verification system; enforcement) hearings and related court matters must be recorded starting January 2, 2003.

A transfer of funds is being requested for the purchase of audio/video recording equipment to accommodate the requirements of the above statute for the Juvenile Justice Center. During preliminary design phase, due to cost considerations, the intent was to reuse existing video/audio equipment. However, it was later determined that the age and condition of the existing equipment was such that it could not adequately support the needs of the court. This equipment also eliminates the need for court reporters (and associated costs) in County court. This equipment will be consistent and compatible with future purchases of recording equipment throughout the County. Comparable JAVS equipment is being installed in the new Criminal Justice Center.
