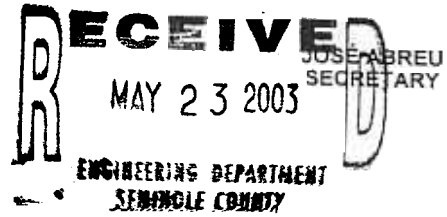

SPECIAL CONDITION FOR PERMIT NO. 03K593-0017

The pavement, coloring and markings installed under this permit will be maintained by Seminole County in good repair. Should the maintenance of the intersections be terminated by Seminole County, all the Street Print markings must be milled and the areas repaved with the original asphalt type and the original pavement markings restored. All costs associated with the maintenance and if necessary, the milling/resurfacing will be borne by Seminole County.
