BACKGROUND:

The applicant, Matthew Joyce, Representative for Waterford Homes is requesting to vacate and abandon a portion of the platted drainage easement (approximately 475 square feet) to allow construction of a swimming pool and pool enclosure located on the most southerly 5 feet of the most northerly 20 feet of Lot 6, Westlake Estates, as recorded in the Public Records of Seminole County, Florida in Plat Book 56, Pages 97 and 98 in Section 30, Township 19 S, Range 30 E. The property is located at 136 Overoaks Place, Sanford, Florida. The proposed vacated area will not diminish the effectiveness of the subdivision's drainage system. The vacation and abandonment of that portion of the drainage easement as requested is necessary to prohibit a potential cloud of title on the property.

STAFF RECOMMENDATION:

Staff recommends adoption of the Resolution to vacate and abandon that portion of the platted drainage easement as requested by Waterford Homes.




