MOTION/RECOMMENDATION:

Approve and authorize Chairman to execute Certificate of Public Convenience and Necessity for Full Pull, Inc. to provide Construction and Demolition Debris Collection Services in unincorporated Seminole County.

BACKGROUND:

Chapter 235 of the Seminole County Code authorizes the Board to regulate the collection and disposal of waste in the unincorporated county. The Board is authorized to issue a Certificate of Public Convenience and Necessity (COPCN) upon completion of an investigation and finding a need for the service. The above company has complied with the requirements as set forth in the Seminole County Code and has requested a COPCN from Seminole County to perform commercial waste collection services in the unincorporated areas of Seminole County.

This firm has provided an application that indicates that they only provide Construction and Demolition (C&D) Debris collection services. Staff has verified this information through follow up telephone conversations. Firms that collect only C&D Debris, Special Wastes, or Recyclables are not required to obtain a non-exclusive commercial solid waste collection franchise. These firms are required to obtain COPCNs.


