BACKGROUND:





A request was received from the Sanford Post Office and Public Safety Department to rename 1st Street, located in the recorded plat of South Sanford Heights Addition, Plat Book 2 Pages 118 & 119. As there are multiple 1st Streets within 4 miles, the 9-1-1 Committee recommended renaming 1st Street to avoid confusion and delays in emergency response.

The property owners abutting this street were notified of the intent to rename 1st Street and were asked to participate in the naming process. The property owners chose the name Lowe Castle Lane. No opposition has been received regarding this street naming.

THE FOLLOWING RESOLUTION WAS ADOPTED BY THE BOARD OF COUNTY COMMISSIONERS OF SEMINOLE COUNTY, FLORIDA, AT THEIR REGULARLY SCHEDULED MEETING OF, JUNE 27, 2006

WHEREAS, under the authority contained in Section 336.05 (1) and 336.05 (2), Florida Statutes, the Board of County Commissioners may name and rename streets and roads; and

WHEREAS, a request has been received to rename an 1st Street located in South Sanford Heights Addition, Plat Book 2 Pages 118 & 119, in Section 12 Township 20 Range 30 Public Records of Seminole County, Florida.

WHEREAS, renaming this street will help to eliminate confusion, facilitate improved emergency access and ability of the public to locate streets and roads within Seminole County, and,

WHEREAS, this change is consistent with overall County plans for street naming, addressing and the 911 system.
