FINDINGS OF FACT, CONCLUSIONS OF LAW AND ORDER

Based on the testimony and evidence presented in case number 02-135-CEB, it is determined that the Respondent is:

- (a) the owner of record of the property (Tax Parcel ID #03-21-29-505-0E00-0130), located at 149 Magnolia Dr., Altamonte Springs, located in Seminole County and legally described as follows: LEG LOT 13 BLK E MOBILE MANOR 2ND SECTION PB 11 PG 48
- (b) in possession or control of the property; and
- (c) in violation of Seminole County Code Chapter 95, Section 95.4 as defined in 95.3 (h).

It is hereby ordered that the Respondent correct the violations on or before 11-8-0. In order to correct the violations, the Respondent shall:

REMOVE THE UNCULTIVATED VEGETATION IN EXCESS OF 24" IN HEIGHT, LOCATED WITHIN 75' OF A STRUCTURE.

If the Respondent does not comply with the Order, a fine of \$\frac{10000}{000}\text{will be imposed for each day the violation continues, or is repeated after compliance past \$\frac{10000}{000}\$. The Respondent is further ordered to contact the Seminole County Code Inspector to arrange for an inspection of the property to verify compliance. Any fine imposed shall continue to accrue until such time as the Code Inspector inspects the property and verifies compliance with this Order.

This order shall be recorded in the official land records of Seminole County and shall constitute a lien against the land on which the violations exists and upon any other real or personal property owned by the Respondent.
