**CELERY CITY CRUISERS
AGREEMENT AND HOLD HARMLESS**

THIS AGREEMENT is made and entered into this _____ day of _____, 2003, by and between **SEMINOLE COUNTY**, a political subdivision of the State of Florida, whose address is Seminole County Services Building, 1101 East First Street, Sanford, Florida 32771, hereinafter referred to as "COUNTY," and **CELERY CITY CRUISERS**, whose mailing address is P.O. Box 560, Sanford, Florida 32772, hereinafter referred to as "CRUISERS".

In consideration of the mutual terms and conditions hereinafter set forth COUNTY and CRUISERS agree as follows:

COUNTY hereby agrees to allow CRUISERS to use the Seminole County Historical Museum grounds located at 300 Bush Boulevard, Sanford, Florida 32771, on November 8, 2003, for the purpose of holding its Antique Car Show, and CRUISERS agree to indemnify and hold harmless COUNTY from and against any and all liability, loss or damage COUNTY may sustain as a result of claims, demands, grievances, costs, judgments or causes of action of every kind and nature whatsoever, including, but not by way of limitation, all liability for property damages and personal injury of every kind, nature or description arising or which may hereafter arise from CRUISERS use of the Seminole County Historical Museum grounds. Exhibit "A," attached hereto and incorporated herein depicts the grounds to be utilized by CRUISERS.

CRUISERS do hereby release and discharge COUNTY, its agents, officers and employees from and against any and all claims, demands, grievances, costs, judgments or causes of action of every kind and nature whatsoever, including, but not by way of limitation, all

liability for property damages and personal injury of every kind, nature or description arising or which may hereafter arise from CRUISERS use of the Seminole County Historical Museum grounds.

CRUISERS shall be responsible for cleaning up and leaving premises in the same condition as they were found. Failure to maintain or clean up the premises used shall result in the COUNTY employing such persons as necessary to bring the premises used up to the condition existing prior to use by CRUISERS. CRUISERS shall be responsible for any costs incurred by the COUNTY for such cleanup services.






