24. Approve Amendment #2 to PS-579-00/BJC – Construction Engineering and Inspection Services for C.R. 419 – Phase I & II, with Reynolds, Smith and Hills, CS, Inc., Plantation (\$122,801.30).

PS-579-00/BJC provides for construction, engineering and inspections (CEI) services necessary to administer the construction contract in such manner to determine that the project is constructed in conformity with the plans, specifications and contract provisions. Amendment #2 will provide for additional CEI Services necessary to be concurrent with the sixty-two (62) day time extension granted to the Construction Contractor. ## SECOND AMENDMENT TO CONSRUCTION ENGINEERING AND INSPECTION SERVICES AGREEMENT (PS-579-00/BJC) C.R. 419 - PHASES I AND II PROJECT

THIS SECOND AMENDMENT is made and entered into this \_\_\_\_\_\_ day of \_\_\_\_\_\_\_, 20\_\_\_\_ and is to that certain Agreement made and entered into on the 2<sup>nd</sup> day of January, 2002, as amended on January 15, 2003, between REYNOLDS, SMITH AND HILLS CS, INC., whose address is 300 South Pine Island Road, Suite 300, Plantation, Florida 33324, hereinafter referred to as "CONSULTANT," and SEMINOLE COUNTY, a political subdivision of the State of Florida, whose address is Seminole County Services Building, 1101 East First Street, Sanford, Florida 32771, hereinafter referred to as "COUNTY".

## WITNESSETH:

WHEREAS, the CONSULTANT and COUNTY entered into the above-referenced Agreement on January 2, 2002, as amended on January 15, 2003 for construction engineering and inspection services for the C.R. 419, Phase I and II Road Construction Project; and

WHEREAS, the parties desire to amend the Agreement so as to enable both parties to continue to enjoy the mutual benefits it provides; and

WHEREAS, Section 22 of the Agreement provides that any amendments shall be valid only when expressed in writing and duly signed by the parties,

NOW, THEREFORE, in consideration of the mutual understandings and agreements contained herein, the parties agree to amend the Agreement as follows:

1. Section 5 of the Agreement is amended to read:

SECTION 5. COMPENSATION. The COUNTY agrees to compensate the CONSULTANT for the professional services called for under this Agreement on a "Time Basis Method" with a Not-to-Exceed dollar amount of ONE MILLION THREE HUNDRED NINETY-THREE THOUSAND FIVE HUNDRED EIGHTY-FIVE AND

95/100 DOLLARS (\$1,393,585.95), including reimbursable expenses. The CONSULTANT shall be compensated in accordance with the Rate Schedule attached as Exhibit "B".

2. Except as herein modified, all terms and conditions of the Agreement shall remain in full force and effect for the term of the Agreement, as originally set forth in said Agreement.


