Snack Vending will provide Pepsi, Coke and snack machines to the Sheriff's Office and remote locations with greater than 200 employees and Snack Time Vending shall pay a commission of 20% on beverage and 15% on snacks. In all other locations (with fewer than 200 employees), Snack Time Vending shall pay a commission of 15% on soda and snack machines.
