

## **BIDS**

- 16. Approve Amendment #3 to IFB-3079-03/GMG – Drink Vending Machine Services Agreement, with Florida Coca Cola Bottling Co., Orlando (Revenue Generating Contract).**

IFB-3079-03/GMG provides for drink vending machine services throughout the County. Amendment #3 will provide for the deletion of all Sheriff's locations and the Sheriff's Office and Public Safety Building. These locations will be served under Contract RFP-4227-04/GMG – Term Contract for Concession Operations Agreement with Snack Time Vending, Inc. The Amendment #1 to RFP-4227-04/GMG is being presented to the Board of Commissioners simultaneously with this item. Administrative Services Department/Support Service's; Sheriff's Office and Fiscal Services/Purchasing and Contracts Division recommend the Board to approve and authorize the County Manager to execute the Amendment.

**THIRD AMENDMENT TO DRINK VENDING MACHINE SERVICES AGREEMENT  
(IFB-3079-03/GMG)**

**THIS SECOND AMENDMENT** is made and entered into this \_\_\_\_\_ day of \_\_\_\_\_, 20\_\_\_\_ and is to that certain Agreement made and entered into on the 9<sup>th</sup> day of February, 2004, as amended on March 3, 2004 and on September 13, 2004, between **FLORIDA COCA-COLA BOTTLING CO.**, whose address is 2900 Mercy Drive, Orlando, Florida 32808, hereinafter referred to as "CONTRACTOR," and **SEMINOLE COUNTY**, a political subdivision of the State of Florida, whose address is Seminole County Services Building, 1101 East First Street, Sanford, Florida 32771, hereinafter referred to as "COUNTY".

**W I T N E S S E T H:**

**WHEREAS**, the CONTRACTOR and COUNTY entered into the above-referenced Agreement on February 9, 2004, as amended on March 3, 2004 and on September 13, 2004, for drink vending machine services; and

**WHEREAS**, the parties desire to amend the Agreement so as to enable both parties to continue to enjoy the mutual benefits it provides; and

**WHEREAS**, Section 19 of the Agreement provides that any amendments shall be valid only when expressed in writing and duly signed by the parties,

**NOW, THEREFORE**, in consideration of the mutual understandings and agreements contained herein, the parties agree to amend the Agreement as follows:

1. Exhibit "B" of the Agreement is amended by the removal of locations for services as indicated on Exhibit "A," attached hereto.

2. Except as herein modified, all terms and conditions of the Agreement shall remain in full force and effect for the term of the Agreement, as originally set forth in said Agreement.
