MOTION/RECOMMENDATION:

Approval by the Board of County Commissioners to expend \$1,000 from the Law Enforcement Trust Fund to contribute to the Salvation Army in Sanford in support of their Family Focus program.

BACKGROUND:

- \$1,000 contribution to the Salvation Army in Sanford.**
 The Salvation Army located in Sanford sponsors the Family Focus program, which provides for a supervised environment for court ordered visitation and exchange for families who have a history of abuse and neglect. By utilizing direct intervention, education, and other techniques, the program has been successful in changing behavior patterns and re-uniting families.
