MOTION/RECOMMENDATION:

Approval by the Board of County Commissioners for the Chairman to sign and process the Certificate of Acceptance for the Florida Department of Law Enforcement Residential Substance Abuse Treatment (RSAT) Program.

BACKGROUND:

The Florida Department of Law Enforcement RSAT grant program will provide up to \$123,462 per year in grant funds to help fund substance abuse services for prisoners that have a minimum sentence of 6 months and a maximum sentence of 12 months. The Budget Amendment request has already been approved at the June 10, 2003 Board of County Commissioners meeting. No new positions are included in this grant. This program provides in jail substance abuse treatment for both male and female inmates that meet the federal program criteria for sentencing. This is the third year of funding for this program.
