MOTION/RECOMMENDATION:

Adopt Resolution naming an unnamed street to Sharps Settlement Lane; and authorize Chairman to execute document.

(District 5 – McLain)

BACKGROUND:

In November of 1950, the west 50 feet of lots 17 and 19, Palm Hammock, Plat Book 1 Page 104, was conveyed to Seminole County for road purposes. The right of way was never officially named or used as an access for the adjoining properties. Over the years, the right of way served as a cut through between Pineway and Palmway. Staff was contacted by a property owner requesting to utilize the right of way as their means of access.

Pursuant to established street naming procedures set forth in Seminole County Ordinance 2000-22, the six property owners adjacent to the right of way were notified of the proposed naming of the right of way to Sharps Settlement Lane. The property owners are in agreement. The County's right of way staff have indicated that a permit will be issued for the request.

Staff recommendation is to name the unnamed right of way to Sharps Settlement Lane.

THE FOLLOWING RESOLUTION WAS ADOPTED BY THE BOARD OF COUNTY COMMISSIONERS OF SEMINOLE COUNTY, FLORIDA, AT THEIR REGULARLY SCHEDULED MEETING OF, AUGUST 26, 2003

WHEREAS, under the authority contained in Section 336.05 (1) and 336.05 (2), Florida Statutes, the Board of County Commissioners may name and rename streets and roads; and

WHEREAS, a request has been received to name an unnamed fifty foot right of way described as the west fifty feet of lots 17 and 19, Palm Hammock, Plat Book 1 Page 104 and adjacent to lot 2, Sharps Subdivision, Plat Book 60 Page 26 and tax parcel 11A located in Section 18 Township 20 Range 31, Public Records of Seminole County, Florida.

WHEREAS, naming this street will help to eliminate confusion, facilitate improved emergency access and ability of the public to locate streets and roads within Seminole County, and,

WHEREAS, this street naming is consistent with overall County plans for addressing and the 911 system.

NOW, THEREFORE, BE IT RESOLVED, that effective, August 26, 2003, the street is named as follows:
