TERM CONTRACTS

28. Approve Amendment #1 to IFB-3056-03/JVP - Term Contract for the Purchase of Water Meter Boxes and Covers, with National Waterworks, Orlando (Price Increase) (Term Contract).

IFB-3056-03/JVP provides for all necessary labor, materials, equipment, transportation, coordination and incidentals necessary to provide water meter boxes and covers to be used by Environmental Services/Water & Wastewater Division on multiple projects throughout the County.

Amendment #1 will provide for a price increase due to the escalations in costs associated with the materials of the waterworks industry. The current Contractor, National Waterworks, Orlando requested an increase for all contracted items. Based on a current Market Survey, the proposed costs with the exception of three line items were found to be competitive and reasonable. These three line items are not considered to be reasonable, and therefore these items will be obtained through another vendor. The list of products and the market survey information are included as part of the backup documents.

Environmental Services /Waste & Wastewater Division and Fiscal Services/Purchasing and Contracts Division recommend the Board to approve the amendment and authorize the County Manager to execute the amendment as approved and prepared by the County Attorney's Office.

FIRST AMENDMENT TO PURCHASE AGREEMENT FOR WATER METER BOXES AND COVERS (IFB-3056-02/JVP)

THIS FIRST AMENDMENT is made and entered into this ______ day of ______, 20___ and is to that certain Agreement made and entered into on the 21st day of February, 2003, between NATIONAL WATERWORKS, INC., whose address is 1820 Metcalf Avenue, Thomasville, Georgia 31792, hereinafter referred to as "CONTRACTOR" and SEMINOLE COUNTY, a political subdivision of the State of Florida, whose address is Seminole County Services Building, 1101 East First Street, Sanford, Florida 32771, hereinafter referred to as "COUNTY".

WITNESSETH:

WHEREAS, the CONTRACTOR and COUNTY entered into the above-referenced Agreement on February 21, 2003 for purchase of water meter boxes and covers; and

WHEREAS, the parties desire to amend the Agreement so as to enable both parties to continue to enjoy the mutual benefits it provides; and

WHEREAS, Section 21 of the Agreement provides that any amendments shall be valid only when expressed in writing and duly signed by the parties,

NOW, THEREFORE, in consideration of the mutual understandings and agreements contained herein, the parties agree to amend the Agreement as follows:

1. Section 5 of the Agreement is amended to read:

SECTION 5. COMPENSATION. The COUNTY agrees to compensate the CONTRACTOR for the professional services called for under this Agreement on a "Fixed Fee" basis. When a Purchase Order is issued for a "Fixed Fee" basis, then the applicable Purchase Order Fixed Fee amount shall include any and all reimbursable expenses. The total annual compensation payable to all CONTRACTORS under IFB-3056-02/JVP shall not exceed the annual sum budgeted by the COUNTY for purchase of water meter boxes and

covers.

- 2. Exhibit "A" of the Agreement is amended by the addition of Exhibit "A", attached, with price increases for items listed thereon.
- 3. Except as herein modified, all terms and conditions of the Agreement shall remain in full force and effect for the term of the Agreement, as originally set forth in said Agreement.
