MOTION/RECOMMENDATION: Adopt and authorize the Chairman to execute a Resolution renaming Truman Street to McKinley Lane.

(District 5 – Commissioner Carey)

BACKGROUND: Truman Street and Truman Boulevard are located in the recorded plat of Lincoln Heights Section1, Plat Book 13, Page 99. Due to the duplication of the street name Truman, there was a delay in emergency response to a 9-1-1 call. To eliminate further confusion and delays in emergency response, the 9-1-1 Committee unanimously recommended a request to rename Truman Street; the Public Safety Department and Sheriff's Office support this request.

The property owners abutting Truman Street were notified of the intent to rename the street and asked to participate in the process. Three street name suggestions were received; Eisenhower, Buchanan and McKinley. Property owners chose the name McKinley Lane. No opposition has been received regarding this street name change.

STAFF RECOMMENDATION:

Staff recommends the renaming of Truman Street to McKinley Lane.

THE FOLLOWING RESOLUTION WAS ADOPTED BY THE BOARD OF COUNTY COMMISSIONERS OF SEMINOLE COUNTY, FLORIDA, AT THEIR REGULARLY SCHEDULED MEETING OF, SEPTEMBER 27, 2005

WHEREAS, under the authority contained in Section 336.05 (1) and 336.05 (2), Florida Statutes, the Board of County Commissioners may name and rename streets and roads; and

WHEREAS, a request has been received to rename a street located in Lincoln Heights Section 1, Plat Book 13 Page 99, abutting Block 1, Lots 1 – 4; Block 2, Lots 23 – 25; Block 3, Lots 15 and 16 and Block 4, Lots 1 – 4; in Section 34 Township 19 Range 30 Public Records of Seminole County, Florida.

WHEREAS, renaming this street will help to eliminate confusion, facilitate improved emergency access and ability of the public to locate streets and roads within Seminole County, and,

WHEREAS, this change is consistent with overall County plans for street naming, addressing and the 911 system.

NOW, THEREFORE, BE IT RESOLVED, that effective, September 27, 2005, the street is renamed as follows:
