SIXTH AMENDMENT TO CUSTODIAL SERVICES AGREEMENT (RFP-4187-03/BJC)

THIS SIXTH AMENDMENT is made and entered into this ______ day of ______, 20___ and is to that certain Agreement made and entered into on the 21st day of July, 2003, as amended on October 13, 2003, October 21, 2004, November 29, 2004, March 10, 2005, and on June 15, 2005, between AlA CLEANING SERVICES, INC., duly authorized to conduct business in the State of Florida, whose mailing address is Post Office Box 520947, Longwood, Florida 32752, hereinafter called the "CONTRACTOR", and SEMINOLE COUNTY, a political subdivision of the State of Florida, whose address is Seminole County Services Building, 1101 East First Street, Sanford, Florida 32771, hereinafter referred to as "COUNTY".

WITNESSETH:

WHEREAS, the CONTRACTOR and COUNTY entered into the above-referenced Agreement on July 21, 2003, as amended on October 13, 2003, October 21, 2004, November 29, 2004, March 10, 2005, and on June 15, 2005 for custodial services; and

WHEREAS, the parties desire to amend the Agreement so as to increase the Scope of Services and the amount of compensation paid to the CONTRACTOR by TWELVE HUNDRED AND NO/100 DOLLARS (\$1,200.00) from September 1, 2005 to October 1, 1005, with an overall increase of five percent (5%) effective October 1, 2005, changes notwithstanding the date this Amendment is executed by the parties; and

WHEREAS, Section 18 of the Agreement provides that any amendments shall be valid only when expressed in writing and duly signed by the parties,

NOW, THEREFORE, in consideration of the mutual understandings and agreements contained herein, the parties agree to amend the Agreement as follows:

- Section 3 of the Agreement is amended to read:
 SECTION 3. COMPENSATION AND PAYMENT.
- (a) The COUNTY agrees to compensate CONTRACTOR for the professional services called for under this Agreement a fee not to exceed the sum of ONE MILLION SEVENTY THOUSAND SEVEN HUNDRED EIGHTY-TWO AND 65/100 DOLLARS (\$1,070,782.65) per year. CONTRACTOR shall perform all work required by the Scope of Services but, in no event, shall CONTRACTOR be paid more than the negotiated Fixed Fee amount stated above. Compensation shall be paid to the CONTRACTOR at the rates as indicated in Exhibit "B" attached hereto
- (b) Payments shall be made to the CONTRACTOR when requested as work progresses for services furnished, but not more than once monthly. CONTRACTOR may invoice amount due based on the total required services actually performed and completed. Upon review and approval of CONTRACTOR'S invoice, the COUNTY shall, within thirty (30) days of receipt of the invoice, pay CONTRACTOR the approved amount.
- 2. Exhibit "A" of the Agreement is amended by the addition of custodial services as indicated on Exhibit "A" attached hereto.
- 3. Exhibits "B" of the Agreement is amended as indicated on Exhibit "B," attached hereto.
- 4. Except as herein modified, all terms and conditions of the Agreement shall remain in full force and effect for the term of the Agreement, as originally set forth in said Agreement.
