MOTION/RECOMMENDATION:

Approve the attached Resolution adopting additional solid waste fees and related rules and regulations.

BACKGROUND:

At the September 23, 2003 meeting, the Board of County Commissioners approved an updated Solid Waste Rate Resolution. At the meeting, the Board removed two paragraphs from the approved Rate Resolution and directed staff to bring the items back for consideration by the Board at a later date. The attached Rate Resolution addresses the two paragraphs that were not approved by the Board on September 23, 2003.

The first section of the attached resolution addresses **Non-Exclusive Franchise Application and Annual Renewal Fees**. This revised section proposes to establish fees for the Non-Exclusive Franchise program at the same level as the fees for the established Certificates of Public Convenience and Necessity (COPCN) program.

Franchise application and annual renewal fee: \$100
Per truck application and renewal fee \$20

The second section of the attached resolution addresses **Municipal Services Benefit Unit (MSBU) Limitations**. In this proposed revision, MSBU customers that pay for curb-side collection of refuse are allowed to deliver up to 12 flat-rate loads to the landfill and transfer station each calendar year. This limitation is requested to control the growth of the costs associated with the solid waste non-ad valorem assessment. Residents that do not receive curb-side collection service are not subject to this limitation. MSBU customers will be allowed 12 deliveries from the date the resolution is adopted through January 1, 2004. After January 1, 2004, they will be limited to 12 deliveries for the calendar year.

THE FOLLOWING RESOLUTION WAS ADOPTED AT THE REGULAR MEETING OF THE BOARD OF COUNTY COMMISSIONERS OF SEMINOLE COUNTY, FLORIDA, ON THE _____ DAY OF _____, 2003.

WHEREAS, the Board of County Commissioners desires to maintain an efficient solid waste management system designed to meet the needs of all Seminole County residents and businesses; and

WHEREAS, the Board of County Commissioners desires to maintain a solid waste management system in compliance with applicable Federal, State, and local regulations; and

WHEREAS, the Board of County Commissioners desires the County solid waste management system to operate within its revenue to the greatest extent possible; and

WHEREAS the Board of County Commissioners has the authority to regulate fees charged at the Seminole County Central Transfer Station (Transfer Station) and the Seminole County Osceola Road Landfill (Landfill) by the Solid Waste Management Division and adopt rules and regulations pertaining thereto from time to time by duly adopted resolution in accordance with Chapter 235, Seminole County Code,

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SEMINOLE COUNTY, FLORIDA:

Section 1. The Board of County Commissioners hereby establishes the following fees for and regulations relating to disposal of waste at the Transfer Station and Landfill:

(a) Non-Exclusive Franchise Application and Annual Renewal Fees. Fees associated with the Non-Exclusive Commercial Solid Waste Collection Service Agreements are as follows:

(b) Municipal Services Benefit Unit (MSBU) Customer Limitations. Residents of unincorporated Seminole County paying the residential non-ad valorem assessment for curb-side collection of solid waste shall be allowed to deliver up to twelve (12) flat rate loads of refuse each calendar year to the Landfill or Transfer Station. After twelve (12) flat rate loads have been delivered from a residence in one (1) calendar year, the applicable disposal fees apply for waste deliveries.

No commercial waste deliveries shall be accepted as part of the pre-paid MSBU customer program.

Section 2. Effective Date. This Resolution shall take effect on the date of execution.
