MOTION/RECOMMENDATION			
Approval and authorization for the Chairman to adopt a resolution authorizing the Solid Waste Collection and Disposal assessments billed on an installment schedule and for establishing the respective lien provisions for such assessments.			

BACKGROUND

As established by Resolution No. 2005 R-159, an installment billing process is offered by the MSBU Program for payment of the annual solid waste MSBU assessment, in lieu of the uniform method of collection (inclusion on property tax bill). The installment billing process requires annual application and timely payment for participation, and is authorized by SW MSBU Ordinance 94-7.

Solid waste assessments billed through the installment method are processed independent of the assessments collected via the uniform method, and are not included in the standard assessment roll prepared separately for Board approval.

The resolution will establish a listing of participating properties and the right to apply lien provisions as appropriate for these assessments. Upon final installment payment of the assessment amount, the lien associated with the assessment is considered satisfied for the year.



THE FOLLOWING RESOLUTION WAS ADOPTED BY THE BOARD OF COUNTY COMMISSIONERS OF SEMINOLE COUNTY, FLORIDA, AT THEIR REGULARLY SCHEDULED MEETING ON OCTOBER 24, 2006.

WHEREAS, the Solid Waste Collection and Disposal Municipal Service Benefit Unit has been created by ordinance for the purpose of providing specific collection and disposal services within the Unit on a continuing basis; and

WHEREAS, each year for each qualifying property within the Unit an assessment is calculated based upon cost of providing the collection and disposal service for the Unit for that year and that annual assessment constitutes a lien upon the lands assessed within the Unit; and

WHEREAS, such assessment is levied upon each parcel of land within the Unit in proportion to the benefits derived from the provisions of such service; and

WHEREAS, certain properties with the Unit request through application the participation in installment billing as an alternative method of collection; and are required to adhere to and specific payment requirements and procedures set forth by MSBU Program; and

WHEREAS, once the total annual assessment is paid for lands assessed, the annual lien for the assessment on those lands is satisfied; and

WHEREAS, for public record and official record purposes it is deemed essential to record annually a list of quarterly billed assessments so that such liens may be easily identified and satisfaction recorded upon payment;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF SEMINOLE COUNTY, FLORIDA, THAT:

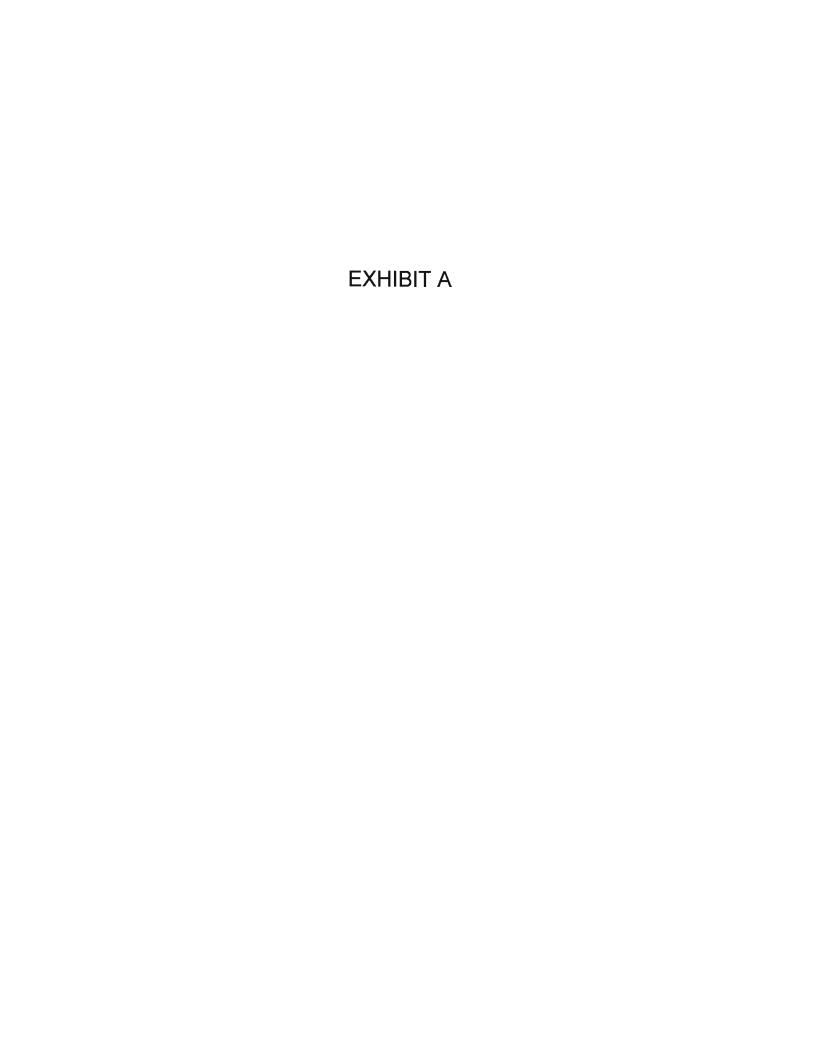
Section 1. Exhibit "A" attached and incorporated herein hereby establishes the assessments for installment billed solid waste collection and disposal services to the Municipal Service Benefit Unit and the parcels listed for the service year January 1, 2007 through December 31, 2007.

Section 2. For each parcel listed, upon payment of the assessment amount for said parcel, the lien for that assessment shall be deemed satisfied.
