R E S O L U T I O N

**THE FOLLOWING RESOLUTION WAS ADOPTED AT THE
REGULAR MEETING OF THE BOARD OF COUNTY
COMMISSIONERS OF SEMINOLE COUNTY, FLORIDA,
ON THE 9TH DAY OF NOVEMBER, A.D., 2004.**

WHEREAS, Commissioner Grant Maloy has served Seminole County, its citizens and residents with the highest level of integrity, honesty, and dedication during his term of office from November 1996, to November 2004, as the Seminole County Commissioner for District One; and

WHEREAS, Grant Maloy grew up in Seminole County, and operates his business, Gabriella Growers, in Seminole County near Oviedo. He is a devoted husband and father and believes that “families” are an important element to our community. He and his wife Althea have been married 13 years and are blessed with three children, Shane 10, Olivia 7 and Bradley 5 years old; and

WHEREAS, Commissioner Maloy worked diligently for the benefit of Seminole County homeowners and residents of District One improving and maintaining the road systems and sidewalks; and

WHEREAS, Grant Maloy was the past President of a Chapter of Citizens Against Government Waste and recognizes that less government translates to more freedom. He continues to advocate cutting taxes, opposing tax increases and the eliminating wasteful spending; and

WHEREAS, Commissioner Grant Maloy has diligently upheld the Commissioners Oath of Office to support, protect, and defend the Constitution and Government of the United States and the State of Florida and faithfully perform the duties of County Commissioner; and

WHEREAS, the Board of County Commissioners wishes to express their appreciation and acknowledgement to Grant Maloy, on behalf of the citizens of Seminole County for faithful service performed for Seminole County and the residents thereof.
