EXTENSION TO SOLID WASTE FRANCHISE AGREEMENT SEMINOLE COUNTY, FLORIDA RESIDENTIAL COLLECTION SERVICE

THIS EXTENSION TO AGREEMENT is made this 28th day of October, 2004, by and between REPUBLIC SERVICES OF FLORIDA, whose address is 110 S.E. 6th Street, 28th Floor, Ft. Lauderdale, Florida 33301, hereinafter referred to as "CONTRACTOR," and SEMINOLE COUNTY, a political subdivision of the State of Florida, whose address is Seminole County Services Building, 1101 East First Street, Sanford, Florida 32771, hereinafter referred to as "COUNTY".

WITNESSETH:

WHEREAS, the CONTRACTOR and COUNTY have heretofore entered into an Assignment dated March 18, 2002, of a certain Agreement between COUNTY and Disposall, Inc. dated May 18, 1994, as renewed on August 24, 1999, and a certain Agreement between COUNTY and Sure Sanitation Services, Inc., dated October 10, 1994, as renewed on August 24, 1999 and collectively referred to as "Agreement" for the provision of residential collection services in unincorporated Seminole County, Florida; and

WHEREAS, said Agreement expires by its terms on December 31, 2004; and

whereas, it is the desire of the parties hereto to extend for three (3) months through March 31, 2005, the terms of said Agreement, together with all other covenants and obligations therein contained,

NOW, THEREFORE, for and in consideration of the covenants and agreements hereinafter set forth, the parties agree as follows:

- 1. Notwithstanding anything contained in the Agreement to the contrary, the term of the Agreement shall be extended for three (3) months, from December 31, 2004, through March 31, 2005, unless terminated sooner as provided for therein.
- 2. Except as herein modified, all terms and conditions of the Agreement shall remain in full force and effect for the term of this

Agreement, as originally set forth in said Agreement. IN WITNESS WHEREOF, the parties hereto have executed this instrument as of the day and year first above written.
