MOTION/RECOMMENDATION:

Approve and authorize the Chairman to execute the amended agreement with United Arts of Central Florida and Seminole Cultural Arts Council, Inc. and the Budget Amendment request for \$105,745.

BACKGROUND:

During the October 25, 2005 Board meeting, discussions were held regarding United Arts of Central Florida and Seminole Cultural Arts Council, Inc. Agreement. Staff was directed to increase the funding to \$.50 per capita and prepare a revised funding structure.

There is currently \$100,000 budgeted for the existing agreement. In order to fund the agreement at the rate of \$.50 per capita that would require an additional \$105,745. The increased amount was derived by using BEBR data that shows the County population in 2005 at 411,490. Therefore, the total funding for the agreement for FY 05/06 will be \$205,745.

The proposed funding structure is based upon splitting the total monies allocated to the arts evenly between the regional arts efforts and the county arts efforts. The Board may

choose to direct that some or all of the additional funds be restricted to support the visual arts. The funding structure outlined on the next page is recommended for FY 05/06, which is the final year of a three (3) year renewable contract. Staff will bring forward recommendations for FY 06/07 during the BCC Budget Work Sessions.

The attached amended agreement modifies Exhibit A, providing for the revised funding structuring FY 2005/06. Also, included for approval and execution is a Budget Amendment request to increase the appropriation for the agreement.

AMENDMENT TO UNITED ARTS OF CENTRAL FLORIDA, INC. AGREEMENT

THIS AMENDMENT is made and entered into this ________ day of _______, 20____ and is to that certain Agreement made and entered into on the 14th day of October, 2003, between SEMINOLE COUNTY, a political subdivision of the State of Florida, whose address is Seminole County Services Building, 1101 East First Street, Sanford, Florida 32771, hereinafter referred to as "COUNTY", UNITED ARTS OF CENTRAL FLORIDA, INC., a Florida not-for-profit corporation, whose mailing address is Post Office Box 940068, Maitland, Florida 32794-0068, hereinafter referred to as "UNITED ARTS", and SEMINOLE CULTURAL ARTS COUNCIL, INC., a Florida not-for-profit corporation, whose mailing address is Post Office Box 4100, Sanford, Florida 32772-4100, hereinafter referred to as "SEMINOLE".

WITNESSETH:

WHEREAS, UNITED ARTS, SEMINOLE and COUNTY entered into the abovereferenced Agreement on October 14, 2003, for the development and awareness of arts and cultural activities; and

WHEREAS, the parties desire to amend the Agreement so as to enable both parties to continue to enjoy the mutual benefits it provides; and

WHEREAS, Section 13 of the Agreement provides that any amendments shall be valid only when expressed in writing and duly signed by the parties,

NOW, THEREFORE, in consideration of the mutual understandings and agreements contained herein, the parties agree to amend the Agreement as follows:

1. Section 6 of the Agreement is amended to read:

Section 6. Funding. The COUNTY hereby agrees to provide financial assistance to UNITED ARTS in the amount of FIFTY-ONE THOUSAND FOUR HUNDRED THIRTY-SIX AND 25/100 DOLLARS (\$51,436.25) on a quarterly

basis up to the maximum amount of TWO HUNDRED FIVE THOUSAND SEVEN HUNDRED FORTY-FIVE AND NO/100 DOLLARS (\$205,745.00) annually. The parties hereby agree that the funds provided hereunder shall be granted to and used by UNITED ARTS and SEMINOLE as set forth in Exhibit "A," including the expenditure of funds for necessary administrative costs; provided, however, that such administrative costs shall not exceed ten percent (10%) of the funding provided by the COUNTY hereunder.

2. Section 7 of the Agreement is amended to read:

Section 7. Payment. Payment of the amounts set forth above shall be made upon receipt by the COUNTY of the following:

- (a) A payment request from UNITED ARTS identifying the amount for which UNITED ARTS seeks COUNTY payment.
- (b) A verification by the COUNTY that UNITED ARTS has complied with the requirements as contained in this Agreement.

- 3. Exhibit "A" of the Agreement is deleted and Revised Exhibit "A" attached hereto is substituted therefor.
- 4. Except as herein modified, all terms and conditions of the Agreement shall remain in full force and effect for the term of the Agreement, as originally set forth in said Agreement.
