**MOTION/RECOMMENDATION:** Adopt and authorize the Chairman to execute a Resolution naming unnamed platted right of way to Dr Edward Stoner Way.

(District 1 – Commissioner Dallari)

**BACKGROUND:** The unnamed platted right of way is located in the recorded plat of Slavia Colony Company’s Subdivision, Plat Book 2 Page 71. At the present time this unnamed platted right of way is known and referred to as Red Bug Lake Road. To avoid confusion and delays in emergency response, the 9-1-1 Committee recommended the unnamed platted right of way to be legally named. The Public Safety Department and Sheriff’s Office support this request.

The property owners abutting the unnamed platted right of way were notified of the intent to name the right of way and asked to participate in the naming process. No addresses will be affected by this action. To date no opposition has been received regarding naming the unnamed platted right of way; additionally, one response was received suggesting Dr Edward Stoner Way.

Dr. Stoner was a prominent physician in the Oviedo area known as “The Community Doctor” During his career and into his retirement, Dr. Stoner held leadership positions in countless medical, civic and charitable organizations as well as served on numerous Boards, Councils and Associations.

Staff recommends naming the unnamed platted right of way. Request Board approval of the suggested name, Dr Edward Stoner Way.


To ensure your vote is counted mail the post card with your preference by October 19, 2005. Per Ordinance duplicate street names will not be approved for use.



RESOLUTION NO. 2005-R-\_\_\_\_\_ SEMINOLE COUNTY,FLORIDA

THE FOLLOWING RESOLUTION WAS ADOPTED BY THE BOARD OF COUNTY COMMISSIONERS OF SEMINOLE COUNTY, FLORIDA, AT THEIR REGULARLY SCHEDULED MEETING OF, NOVEMBER 15, 2005

WHEREAS, under the authority contained in Section 336.05 (1) and 336.05 (2), Florida Statutes, the Board of County Commissioners may name and rename streets and roads; and

WHEREAS, a request has been received to name a street located in Slavia Colony Company's Subdivision, Plat Book 2 Page 71, in Section 21 & 22 Township 21 Range 31 Public Records of Seminole County, Florida.

WHEREAS, naming this street will help to eliminate confusion, facilitate improved emergency access and ability of the public to locate streets and roads within Seminole County, and,

WHEREAS, this change is consistent with overall County plans for street naming, addressing and the 911 system.
