Approve Amendment #4 to RFP-4117-01/GG - Display Wall & Display Wall Controller for Seminole County Advanced Traffic Management Controller, with Advanced Video Inc., Columbia, SC (Not-to-Exceed \$48,160.80) (Time Extension).

Contract RFP-4117-01/GG provided for the installation of a Display Wall and Display Controller System as part of the Control Center for the County's Advanced Traffic Management System (ATMS). The display system is installed in the 911 Operations Center located in the Public Safety Building. The wall installation project was completed successfully in December 2002 and an initial warranty of one (1) year was included with the original contract. This warranty expires in December 2003. Amendment #4 will provide for additional warranty time and contract extension for a period of four (4) years, December 31, 2007. The warranty will cover the wall hardware and software and will include an annual preventive maintenance component. The purpose of the additional warranty is to cover unforeseen equipment problems and extend the life expectancy. The following is the summary of the cost of the contract:

FOURTH AMENDMENT TO DISPLAY WALL AND DISPLAY CONTROLLER SYSTEM INSTALLATION AGREEMENT (RFP-4117-01/GG)

THIS FOURTH AMENDMENT is made and entered into this _____ day of ______, 20___ and is to that certain Agreement made and entered into on the 27th day of July 2001 between ADVANCED VIDEO, INC., whose address is 400 Northeast Drive, Suite C, Columbia, South Carolina, 29224, hereinafter referred to as "CONTRACTOR," and SEMINOLE COUNTY, a political subdivision of the State of Florida, whose address is Seminole County Services Building, 1101 East First Street, Sanford, Florida 32771, hereinafter referred to as "COUNTY".

WITNESSETH:

whereas, the CONTRACTOR and COUNTY entered into the above-referenced Agreement on July 27, 2001, as amended on February 13, 2003, November 18, 2002, and on December 24, 2002, to provide design, labor, materials, cables, tools, transportation, supervision, coordination, testing, documentation, integration, and warranty services for a complete installation of a display wall and display controller system as part of the Control Center for Seminole County's Advanced Traffic Management System in Seminole County; and

WHEREAS, the parties desire to amend the Agreement so as to enable both parties to continue to enjoy the mutual benefits it provides; and

whereas, Section 19 of the Agreement provides that any amendments shall be valid only when expressed in writing and duly signed by the parties,

NOW, THEREFORE, in consideration of the mutual understandings and agreements contained herein, the parties agree to amend the Agreement as follows:

1. Section 3 of the Agreement is amended to read:

SECTION 3. FIXED FEE COMPENSATION AND PAYMENT.

- (a) The COUNTY agrees to compensate CONTRACTOR for the professional services called for under this Agreement a fixed fee in the amount of FOUR HUNDRED EIGHTY-SEVEN THOUSAND SIX HUNDRED TWELVE AND 80/100 DOLLARS (\$487,612.80). CONTRACTOR shall perform all work required by the Scope of Services but, in no event, shall CONTRACTOR be paid more than the negotiated Fixed Fee amount stated above.
- (b) Payments shall be made to the CONTRACTOR when requested as work progresses for services furnished, but not more than once monthly. CONTRACTOR may invoice amount due based on the total required services actually performed and completed. Upon review and approval of CONTRACTOR'S invoice, the COUNTY shall, within thirty (30) days of receipt of the invoice, pay CONTRACTOR the approved amount.
 - 2. Section 8 of the Agreement is amended to read:
- SECTION 8. TERM. This Agreement shall take effect on the date of its execution by COUNTY and shall remain in effect until December 31, 2007.
- 3. The Scope of Services attached to the Agreement is amended by the addition of services as indicated in Exhibit "A," attached hereto.
- 4. Except as herein modified, all terms and conditions of the Agreement shall remain in full force and effect for the term of the Agreement, as originally set forth in said Agreement.
