BACKGROUND:						
 Community Services Block Grant (CSBG) funding has been granted to Seminole County since Fiscal Year 1987/88. The acceptance and use of CSBG funds requires a Board of Directors (comprised of nine members) as follows: a. One-third of the members of the Board as elected officials currently holding office, (representing the three CSBG targeted areas of Altamonte Springs, Oviedo, and Sanford with one member each); b. One-third of the members as persons chosen in accordance with the demographic selection procedures (Town Meetings) to assure representation from target areas; c. One-third of the Board as representatives from the private sector, officials or members of business, labor, industry, religious or other major groups in the community. 						
 The following are recommended to fill existing vacancies: a. Elected Official: Appointment of <u>Steve Henken</u>, selected by Oviedo City Commission, for the term: October 18, 2006 to October 18, 2011. b. Target Area Representative-District I: Appointment of <u>Charlie Morgan</u> to represent the Lake Monroe area, for the term: August 25, 2006 to August 25, 2008. c. Private Sector Representative: Appointment of <u>José Valcarcel</u> to represent the private sector, for the term: November 17, 2006 to <u>Co Atty:</u>
