

RESOLUTION

THE FOLLOWING RESOLUTION WAS ADOPTED AT THE REGULAR MEETING OF THE BOARD OF COUNTY COMMISSIONERS OF SEMINOLE COUNTY, FLORIDA ON THE 14TH DAY OF DECEMBER A.D., 2004.

WHEREAS, H.W."BILL" SUBER, whose family settled in Florida in the 1800's, and who was born in Gadsden County, Florida, has served the citizens of Seminole County with the highest level of integrity, dedication and expertise during his terms of office from October 1980 through January 2005 as the Seminole County Property Appraiser; and

WHEREAS, BILL SUBER's Constitutional responsibilities to the citizens of Seminole County included identifying, locating and fairly valuing all property, both real and personal, within Seminole County for tax purposes, with his philosophy to provide superior customer service and access to public information, led him to be a pioneer and award-recipient in the development of internet-based access to property information; and

WHEREAS, BILL SUBER was employed by the Seminole County Property Appraiser in 1969 as an appraiser and subsequently was promoted to Assistant Property Appraiser in 1973, remaining in that capacity until his election to office in 1980, providing property owners a superior level of service, accuracy, value and equity while exercising his duties to Seminole County; and

WHEREAS, BILL SUBER, a Certified Florida Appraiser and American Society Appraiser, has served with distinction as Past President of the Florida Association of Property Appraisers (FAPA), Past President of Property Appraiser Association of Florida (PAAF), Past Treasurer of the American Society of Appraisers-Orlando Chapter, served on various committees for the International Association of Assessing Officers (IAAO), was a founding member of the Florida Chapter of IAAO, and served many years as the Legislative Chair for FAPA representing the interests of Florida's taxpayers; and

WHEREAS, BILL SUBER has been the recipient of numerous awards, including: FAPA's President's Award on five occasions, FAPA's Herb Lockey Award on three occasions, and most recently, the IAAO (Florida Chapter) Neil Hester Award for Exemplary Service; and

WHEREAS, BILL SUBER served the citizens of the State of Florida on various statewide committees, including the Florida Advisory Council On Intergovernmental Relations (appointed by Governor Bob Martinez), the Florida Ad Valorem Task Force (appointed by Governor Lawton Chiles), and the Property Tax Administration Task Force (appointed by the Florida Department of Revenue); and

WHEREAS, BILL SUBER has involved himself in the community through his participation in the Sanford/Lake Mary Chapter of the American Cancer Society as Past President and current Board Member, Committee Member of the Orlando Chapter of Ducks Unlimited, Board Member of the Good Samaritan Home, and as a Member of the Fraternal Order of Masons; and

WHEREAS, the Board of County Commissioners wishes to express its appreciation on behalf of the citizens and residents of Seminole County, Florida to BILL SUBER and desires to acknowledge his conscientious and faithful service upon his retirement.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of Seminole County, Florida that this Resolution be spread upon the Official Minutes by the Clerk of the Circuit Court in and for the County of Seminole in recognition of BILL SUBER's thirty-five years of service to the citizens of Seminole County.

BE IT FURTHER RESOLVED that this Resolution be presented to H. W. "BILL" SUBER with our sincere best wishes for his continued good health and happiness with his wife, Terry, his children and grandchildren, and much success in all future endeavors.
