MOTION/RECOMMENDATION:		
Approve and authorize the Chairmen to execute the agreement with ACIPCO and DMD Consultants Inc. for the repairs of 208 American Darling Fire Hydrants.		

The American Darling Fire Hydrant Manufacturer has determined that certain hydrants sold between 1999 and 2003 contain an additive to the grease that may cause the hydrant to malfunction. We have identified 208 American Darling Fire Hydrants Model 5½ inch B84B in our systems that will need to be repaired by the manufacturer. The executed agreement will allow the manufacturers representative to repair at no cost to the County the 208 identified hydrants.

SERVICE AGREEMENT

THIS SERVICE AGREEMENT ("Agreement") is made and entered into as of the 28 day of 2005, by and between AMERICAN CAST IRON PIPE COMPANY, a Georgia corporation ("ACIPCO"), whose address is 1501 31st Avenue North, Birmingham, Alabama 35202; SEMINOLE COUNTY (the "County") with offices at 1101 East 1st Street, Sanford, Florida 32771; and DMD CONSULTANTS, INC., a Florida corporation ("Contractor"), whose address is 11020 82st Ct. N., Palm Beach Gardens, Florida 33412.

ACIPCO has sold fire hydrants to the County, and certain hydrants sold are in need of repair. ACIPCO desires to retain Contractor and Contractor desires to be retained for the purpose of repairing the fire hydrants identified by the County and listed in Exhibit A attached hereto, upon the terms and conditions set forth in this Agreement. ACIPCO has agreed, pursuant to the terms and conditions of this Agreement to pay for Contractor's services with regard to such hydrants.

- 1. Term: Exhibit A sets forth the location by city, county or otherwise of the hydrants in need of repair (the "Hydrants"). ACIPCO hereby engages the Contractor to perform service and repair on the Hydrants. The Contractor shall coordinate with the County as to the exact location of each Hydrant. Contractor shall complete repair of all Hydrants on or before the date set forth on Exhibit A. ACIPCO shall supply the Contractor with one kit for each Hydrant to be repaired. Each such kit shall contain all of the parts necessary to repair one hydrant. Upon completion, Contractor shall provide the County with notice and certification that the Hydrants have been repaired in accordance with the terms of this Agreement and a copy of such notice and certification shall be sent to ACIPCO.
- Contractor's Duties: In performing the repair of the Hydrants, Contractor agrees: (a) To fully perform, at its sole cost and expense, and in a timely fashion, the repair of the Hydrants. Contractor agrees that the repair of the Hydrants is ordinary and common in the industry in which Contractor is engaged. Contractor shall have complete authority over its personnel and its duties hereunder; provided however, the County reserves the right, but has no obligation, to inspect the work performed by Contractor in order to insure compliance with the specifications of the safety and duties to be performed hereunder. Contractor further agrees to perform Contractor's duties hereunder in a good and workmanlike manner, and in accordance with industry standards established by those engaged in a business similar to that of Contractor in performance of said duties; and (b) To obtain and pay for all applicable permits and licenses necessary and incidental to the performance of said contract duties and to otherwise comply with all governmental laws and regulations pertaining to the performance of said contract duties, and to save the County and ACIPCO harmless from any liability which may arise from the failure of Contractor to secure such permits and licenses or otherwise comply with all such governmental laws and regulations; and (c) To provide competent and well trained on-site personnel for performance of said contract duties at all times when said duties are being performed; and (d) To supervise all personnel representing Contractor through designated representatives of Contractor who will be available at reasonable times to consult with the County, ACIPCO, or either party's designated representative; and (e) To maintain a "safe work place", so as to insure the safety of all persons on the site; and (f) to make the County aware of any potentially dangerous situation in writing upon discovery of such situation; and (g) To comply with all applicable environmental laws and regulations; Contractor acknowledging that the Hydrants are owned by the County.
- 3. <u>Contractor's Compensation</u>: As full compensation to Contractor for its services hereunder, ACIPCO shall pay Contractor forty dollars (\$40) per hydrant. ACIPCO shall pay Contractor within 30 days of receipt of Contractor's invoice and a copy of the notice and certification of completion as set forth in Section 2 hereof. Any terms and conditions contained on Contractor's invoice or quotation are hereby rejected and not a part of this Agreement.
- 4. <u>Additional Work</u>: ACIPCO is responsible for paying Contractor forty dollars (\$40) per Hydrant as specified in Paragraph 3 above, only for such Hydrants that are repaired by Contractor utilizing a kit supplied by ACIPCO. If during the course of performing its duties under this Agreement, the Contractor becomes aware

of other damage to or other repair work that needs to be performed on one or more of the Hydrants which is unrelated to the repair work under this Agreement, the Contractor shall notify the County. Upon receipt of verbal authorization from the County, the Contractor shall make such repairs and invoice the County for such efforts. The County shall provide written authorization for the repair work to the Contractor within ten (10) business days. The County agrees to be responsible for payment of all such additional work. The Contractor hereby acknowledges and agrees that ACIPCO does not authorize and shall not be responsible for the cost of any such additional work.

- 5. <u>Insurance Requirement</u>: Prior to commencement of Contractor's work on each applicable Hydrant hereunder and for the duration of the work, Contractor shall procure and maintain workers' compensation, comprehensive general liability (with limits not less than \$2 million per occurrence and \$5 million in the aggregate), automobile, public liability, and property damage insurance in amounts and coverage sufficient to cover all claims under this Agreement. A Certificate of Insurance must be provided to the County and to ACIPCO at least three (3) business days prior to commencement of the duties established herein, evidencing that such insurance is in full force and effect, naming the County, ACIPCO and their respective partners, agents, servants, employees, and officers as additional insureds, and providing that such insurance is primary with respect to claims made by the additional insureds. Such certificate must provide that said insurance will not be changed or canceled without at least ten (10) days written notice by certified mail, return receipt requested, to the County and ACIPCO at the above addresses. Contractor agrees to save the County and ACIPCO harmless from and against any Claim (hereinafter defined) resulting from the failure of Contractor to comply with the provisions of this Section.
- Indemnification: Contractor agrees to assume liability for and shall indemnify, protect, save, and keep harmless the County and ACIPCO, together with their partners, agents, servants, employees and officers (the "Indemnified Parties") from and against any and all claims, actions, damages, liabilities, suits, obligations, losses, penalties, court costs, attorneys fees, and expenses of whatever kind and nature imposed on, asserted against, or incurred by any of the Indemnified Parties (collectively, "Claims") in connection with the loss of life, personal injury, emotional harm, defamation, damage to property, or other losses arising from the performance of or failure to perform the contract duties established herein or any other duty imposed upon Contractor, et al. pursuant hereto, or any other act or omission of Contractor, et al. (as used herein, the term "Contractor, et al." shall be deemed to include Contractor's officers, directors, agents, contractors, employees, servants, invitees, and licensees, as the case may be). The aforesaid obligation of indemnity shall be construed so as to extend to all legal, defense, and investigative costs, as well as all other reasonable costs, expenses, and liabilities incurred by the Indemnified Parties, from and after the time at which any such Indemnified Party receives notification (verbal or written) that a claim or demand is to be made or may be made. In connection with any such Claims, the County and ACIPCO each expressly retain the right to be represented by attorneys of their own selection, at their own expense. The exercise of the County's right or ACIPCO's right to select its own attorneys will in no way detract from or release Contractor from Contractor's obligation to indemnify and hold the County and ACIPCO harmless hereunder.
- 7. <u>Assignment and Delegation</u>: Contractor shall be absolutely prohibited from assigning or delegating (or attempting to assign or delegate) this Agreement (or any right, obligation or performance of Contractor hereunder); it being agreed that the services to be performed hereunder are personal in nature.
- 8. Relationship of Parties: Contractor is retained by ACIPCO only for the purpose and to the extent set forth herein, and Contractor's relationship with the County and ACIPCO shall, during the entire term of this Agreement, be that of independent contractor so that neither Contractor, nor any employee, agent, servant, officer, director, or shareholder of Contractor shall be deemed an agent, servant, or employee of the County or ACIPCO. Contractor agrees to indemnify and hold the County and ACIPCO harmless of and from any and all Claims arising from any determination (whether judicially or administratively) that some relationship, other than that of independent contractor, exists between the County, ACIPCO, and Contractor.

- 9. <u>Amendment or Modification</u>. This Agreement shall not be modified or amended except by a writing signed by all parties.
- 10. <u>No Waiver</u>: Failure of any party at any time to require performance by any other of any provision hereof shall in no way affect the full right to require such performance at any time thereafter, nor shall the waiver by either party of a breach of any of the provisions hereof constitute a waiver of any succeeding breach of the same or any other provision.
- 11. <u>Severability</u>: If any provision hereof is deemed to be invalid or unenforceable under applicable law, this Agreement shall be considered divisible as to such provision and the same shall thereafter be inoperative, provided, however, the remaining provisions of this Agreement shall be valid and binding notwithstanding.
- 12. <u>Applicable Law</u>: This Agreement is deemed made and entered into within the State of Florida and is to be governed by as well as construed and interpreted according to the laws of said state.
- 13. <u>Attorneys' Fees</u>: In the event of litigation arising out of or in connection with this Agreement, the non-prevailing party agrees to pay to the prevailing party, the prevailing party's reasonable attorneys' fees and costs of suit, including fees and costs of appeal.

14. Miscellaneous:

- a. Contractor shall neither suffer nor permit the attachment of any liens upon the Premises as a direct result of Contractor's performance of the contract duties established herein.
- b. If Contractor shall default in the performance of the contract duties established herein or any other duty imposed upon Contractor hereunder, the County and/or ACIPCO may (but shall not be required to), without notice to Contractor, cure and rectify such default and either deduct the reasonable cost of cure and rectification from compensation due to Contractor hereunder or directly bill Contractor for such reasonable costs.
