

RESOLUTION 01-1279

“**_____**, FLORIDA, AUTHORIZING SEMINOLE COUNTY TO RENAME PLATTED STREETS; PROVIDING FOR CONFLICTS, SEVERABILITY, AND EFFECTIVE DATE.”

WHEREAS, under the authority contained in Section 336.05(1); and Section 336.05(2), Florida Statutes, the Seminole County Board of County Commissioners may name and rename streets and roads; and

WHEREAS, a request has been made of the City of Casselberry by Seminole County to rename streets as indicated on the table below affecting the indicated plats; and

WHEREAS, renaming these streets will help to eliminate confusion, facilitate improved emergency access and ability of the public to locate streets and roads within the City of Casselberry; and

WHEREAS, these changes are consistent with the overall Seminole County plans for street naming, addressing and the Emergency 911 system.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF CASSELBERRY, FLORIDA, AS FOLLOWS:

SECTION I. The street names as recorded in the following plats shall be renamed as the City's street sign names and as shown in Attachment "A":
